Freemans Bridge Rehabilitation
City of Schenectady and Town of Glenville, Schenectady County
NYSDOT Contract D264016

Gentlemen:

We are pleased to advise that, weather permitting, our contractor is scheduled to begin work on the above-referenced project with site preparations starting on **Monday, March 23**. If weather or other conditions are not conducive to this work beginning on that date, it will begin as soon as possible afterward. We expect that this work will be completed by the end of November 2020.

In order to provide a safe work area while maintaining traffic flow, during two stages of construction extending roughly from **April 6 through October 15**, we will need to prohibit turn movements between Freemans Bridge Road and Maxon Road Extension (left turns from Freemans Bridge to Maxon Extension, and right turns from Maxon Extension to Freemans Bridge). Motorists intending to make these movements will be directed down Erie Boulevard to the Nott Street/Rush Street roundabout at the Rivers Casino entrance, where they will return to northbound Erie Boulevard and complete their movements. The traffic control plan will maintain a single lane in each direction, plus pedestrian accommodations across the bridge, at all times. All properties in the area will continue to be accessible during construction.

We are providing area businesses with an informational flyer (copy enclosed) for their use in advising visitors and delivery people of the detour period and turn restrictions.

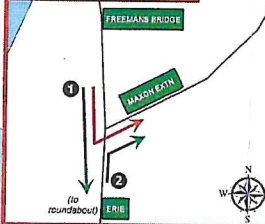

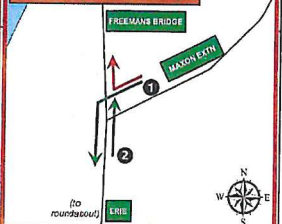
