Section 255- $\qquad$ : Authority
A. The Highway Superintendent and Department of Public Works, shall install and maintain traffic control devices when and as required under the provisions of this chapter to make effective the provisions of said chapter and to install and maintain such additional traffic control devices as the Town Board may deem necessary to regulate, warn or guide traffic under the Vehicle and Traffic Law of the State of New York subject to the provisions of $\S \S 1682$ and 1684 of that law.
B. Any official traffic control device or traffic control signal placed within the Town of Glenville and purporting to conform to the lawful requirements pertaining to such devices or signals shall be presumed to comply with the requirements pertaining to such devices or signals, unless the contrary shall be established by competent evidence.

Section 255- $\qquad$ : Failure to Obey an Overhead Clearance Sign

No person shall operate or move a vehicle or combination of vehicles over, on or through any bridge, viaduct or other structures on any highway which exceeds the height of the posted clearance as shown by an official sign or other marking or device.

Section 255-13(__): Penalties for Offenses
Every person convicted of a traffic infraction of Section 255- $\qquad$ of this chapter shall be punishable by a fine of not more than $\$ 450.00$ or by imprisonment for not more than 15 days, or by both such fine and imprisonment.
