Supervisor Koetzle called the meeting to order at 7:00 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Brett Cotton, 160 Van Buren Road – Mr. Cotton spoke regarding the Glenville Dog Park. He stated that it was a wonderful addition to the community and that he uses it daily. He stated that residents are having an issue with out-of-town or unregistered dogs in the park. He has been witness to a few attacks on other dogs and he is concerned it is going to escalate into an attack on other people. He stated that there is no good way to communicate with the Dog Control Officer at that moment. He informed the Board that the Village of Scotia has an electronic pass that allows people in and out. There are no phone numbers available at the park and he feels that would be very helpful. He also stated that the garbage in the park is not emptied on a regular basis. He also feels that there should be another drinking fountain inside the gated area. He stated that the grass in the large dog area is getting wore out and there is no grass left in certain areas. He also asked if benches could be add inside the fenced area.

WHEREAS, New York State Empire State Development Corporation requires that an applicant leverage additional resources, including a minimum of 50% of the total project cost in matching funds, including at least a 10% cash equity match, and

WHEREAS, the Town of Glenville agrees to contribute 50% of the total project cost in the form of a 10% monetary contribution (\$10,000 local cash match) and inkind services valued at

\$40,000;

NOW THEREFORE BE IT RESOLVED, that the Glenville Town Board hereby authorizes the Town Supervisor to file a 2017 Consolidated Funding Application for funds from the New York State Empire State Development Corporation in the amount of \$50,000 to conduct a strategic development plan for a greenway trail system, and upon approval of said funding request, to execute a project grant agreement with NYS for such financial assistance; and

WHEREAS, the New York State Department of State is providing funding under the 2017 Consolidated Funding Application (CFA) process through the Local Waterfront Revitalization Program for qualified projects that focus on construction of land and water based trails to create physical linkages between community centers, waterways, parks, open spaces, businesses, and historic, scenic and cultural sites, and

WHEREAS, it is estimated that the total project cost to reconstruct the Scotia-Glenville portion of the Mohawk-Hudson Bike-Hike trail would be approximately \$325,400; and

WHEREAS, New York State Department of State requires that an applicant leverage additional resources, including a minimum of 25% of the total project cost in matching funds, and

WHEREAS, the Town of Glenville agrees to contribute 25% of the total project cost in the form of a 13% monetary contribution (\$42,302 local cash match) and in-kind services valued at \$39,048;

NOW THEREFORE BE IT RESOLVED, that the Glenville Town Board hereby authorizes the Town Supervisor to file a 2017 Consolidated Funding Application for funds from the New York State Department of State in the amount of

\$244,050 to reconstruct the Scotia- Glenville portion of the Mohawk-Hudson Bike-Hike Trail, and upon approval of said funding request, to execute a project grant agreement with NYS for such financial assistance; and

WHEREAS, a Petition and Notice to Review the Assessment for taxation for the tax years 2015, 2016 and 2017 of the real estate owned by Shady Lane Realty, Inc., commonly known as 115 Saratoga Road, Glenville, New York (S/B/L # 22.18-1-5.11/1) was duly served upon the Assessor in July, 2015, July 2016 and July 2017 respectively; and

WHEREAS, the Town, through its attorney and the Assessor are prepared to enter into an agreement and stipulation of compromise and settlement of their differences as follows:

That the proceedings for tax years 2015, 2016 and 2017 in relation to the property be settled on the following terms and conditions:

- 1. This settlement is made in resolution of all past and present claims or proceedings with respect to the subject property's real property tax assessment;
- Approval of this settlement and all required authorizations and enactments by the necessary parties shall be made in good faith and as expeditiously as possible;
- 3. Pursuant to Real Property Tax Law section 727, the proceeding for 2015 and later years shall be settled by establishing the assessment of the property at the revised assessed value of \$7,600,000.00 for the 2015 tax roll, \$7,900,000.00 for the 2016 tax roll and \$8,200,000.00 for the 2017 tax roll. That the Comptroller is authorized to calculate the amount of any refund for 2016 and 2017 Town, Highway and Special District taxes already paid and to pay same over to the property owner upon receipt of a fully executed stipulation.
- 4. It is further stipulated and agreed that the assessed value for 2018 and 2019 shall be established at \$8,200,000 and the assessed value for 2020 and 2021 at \$8,400,000.
- 5. All other provisions of the RPTL section 727, including RPTL 727 (2) shall apply to this settlement. That is, the property owner agrees not to bring another tax certiorari proceeding with respect to this property for the three years following the affected tax year unless the improvements on the property shall be destroyed, demolished or removed and the Assessor agrees to maintain the assessment based upon the revised full market value for those three years unless required by additions, alterations or capital improvements or in the event of a revaluation.
- 6. In consideration hereof, the tax certiorari proceedings brought by the taxpayer shall be discontinued on the merits with prejudice and without costs to either party or against the other.

7. The parties agree that the Stipulation is entered into for good and valuable consideration, that it is the entire agreement of the parties, that it is made to resolve this litigation and shall not be offered in any other proceeding by any party as competent evidence of any fact, that the stipulation may be filed in the office of the Schenectady County Clerk and an Order may be entered, based upon the Stipulation by either party on notice to the other.

WHEREAS, it appears to be in the best interests of the Town to settle said matter as recommended by the Attorney for the Town and the Assessor without further attendant legal and appraisal costs; and

WHEREAS, the property is located in the Scotia - Glenville School District, and the District has no opposition to the proposed settlement;

NOW THEREFORE, BE IT RESOLVED that the Town Board of the Town of Glenville hereby authorizes the Attorney for the Town to enter into an agreement with the Shady Lane Realty, Inc. for the settlement of the tax certiorari proceedings brought relative to the property known as 115 Saratoga Road under the terms outlined above.
