#### **Town Council Reports**

**Councilman Godlewski:** I attended the Berkley Square Halloween Parade and costume contest; we had a lot of fun my family attended. My family for the second year in a row won best family costume. I was incredibly proud and pleased with that. It was a fun event and always a good time it's a great neighborhood. I wanted to mention I know our Town Clerk, Ms. Davenport, has been highly involved in the Tree Lighting Ceremony on Dec. 3 from 6-8 PM and the new addition a Chowder Festival, ticket sales \$2 and the proceeds will benefit Toys for Tots. I shared a post on Facebook and it got a ton of hits and its spreading and I belive its going to have a great turn out.

**Councilwoman Wierzbowski:** I just wanted to take a moment and recognize the hard work and efforts of our Water & Sewer Department and DPW employees, Tom Coppola and all others who assisted on the huge water main break on Glenridge Road. I know that was an interruption and a great inconvenience to many, many people, they fixed things as quickly as possible and made the repairs as efficiently as they could. I just want to thank the residents for their patience and more importantly the employees for their work over the entire weekend.

**Councilman Martin:** I continue to read through our respondents to our Request for Qualifications regarding a potential new Town Hall project. I think its very exciting, we have four fine qualifications came in and I'm excited about the prospects of that. Going forward we will transition to Request for Proposals, we will get more detail and some further information, its going very well. I participated in the interview for our Planning Director, resulting in a resolution I'm pleased to see tonight and I welcome Tony. He has a lot of experience and I am very excited to see what he is going to bring that department.

## Supervisors Comments to the Board

Just a few things to catch you up on, some of the things going on in the past week or two. First of all, on the budget, I just want to point out that we did get our third quarter Metroplex sales tax check, which as you probably already know sales tax is up everywhere. Counties are flush with money coming in on sales tax. This sales tax check came in earlier than most years and it was an increase, \$80,000, an increase over last year which makes it our highest ever third quarter amount. So, year to date, we're now tracking 8% above last year's total, so that's good news. Barring fourth quarter collapse, we should hit about 1.1 million Metroplex sales tax this year, setting new record for us. So that's the good.

The bad news our energy prices continue to climb, just like everybody else. We expect our electric bills to end roughly 30% above our 2021 totals. In dollar terms, this would be a price increase of about \$90,000, this year. Unfortunately, the short-term outlook into the start of 2023 doesn't look that great either, we expect energy prices to be high. Jason and I met with our energy consultant and we're taking the proper prudent steps to try to protect against spikes going into the winter. We're looking at a mix of locking in rates, some longer, so a base of say 25% locked long term. Another 50% locked short term through the winter and then 25 to ride. We think that's a reasonable approach. You know, if we lock in completely, we're doubling our energy costs. So, we want to let it ride a little bit and take some risk out of this winter and we're working on doing everything to mitigate those increases. But as you're going to see in your own home heating bill and everybody else it's going to be a painful winter. Some are saying now that it looks to be potentially a mild winter and that will be the best news for everybody but we'll see where it goes, we're expecting to see a spike in that line. Similarly, our gas and diesel bills also remain stubbornly high. In 2021, we spent \$230,000 on gas and diesel for the entire year. So far in 2022, were already at 265,000 and we still up two months ago. Potentially at least one of those is a snow plowing month. So that bill is getting up on us as well. So, we'll likely end 2022 with a \$100,000 increase in gas and diesel expense over point.

To just report last meeting, I told you that I'll be meeting with the county to talk about the Alplaus sidewalk trying to get that going forward. Unfortunately, there was a cancellation of that meeting last minute, we did not have that meeting. But on a similar note, I also did get the call from the Champlain Hudson Power Line that they did close on financing, so the money to do the rest of the sidewalk is now on its way, and we now have all the money we need to go forward. I think at this juncture we are just going to just engineer it and move forward, that's all we can do. We've done everything, talked to the county and it isn't working out. We have the grant we have set aside money; we now have this \$80,000 so it's just time to move forward and so that's our next item on our agenda we will be doing that.

I got a pleasant surprise from DEC the other day, we've been lobbying the past couple years, if you all remember, we started cleaning up the Kenco site. Then all of a sudden

Hoosick Falls happened and the State diverted all the resources to Hoosick Falls. We fell off the cleanup list, lost our money and they left us half done. Well, we've been lobbying hard and now I got confirmation that the Kenco site is back in the budget. So that's going to get started again, I don't have any details to when or what's going to happen but at least it's back on the DEC's radar. So that's very good.

As you notice, we're knocking down half a Freemans Bridge Rd. We're issuing permits for the solar farm to start shortly and will be a demolition of the whole Sarnowski Farm. From there we're talking to some others about future projects, but we are starting to get to the point where we're getting Freemans Bridge Rd shovel ready. When we talked to Tony on the interviews that is one of the priorities is to get Freemans Bridge Road up and off the ground. I think we're getting to that point where we have almost a blank slate.

The other good news we finally got was DOT and the rail companies are ready to meet with the Town on fixing the Freemans Bridge Rd rail crossing. I couldn't stay in the meeting it was a webinar but Commissioner Craig was on that meeting, so he'll fill me in tomorrow on what was, finally settled. It looks like potentially this year. We met with DOT a couple weeks ago and talked about a resurfacing improvement of Freemans Bridge Rd next year and doing the permanent crossing with the pedestrian arm there. But it looks like we're going to do a temporary fix, so a lot of good news going on in regards particularly on Freemans Bridge Road and we are excited about that.

Lastly, on the personnel front, Jim alluded to it a little bit. We're very excited to have three new hires on the agenda tonight. Which we'll get to very shortly and I know two of them are here and the 3rd is not. We are excited to bring them on board and it's going to be a great fit. All very impressive people. So welcome and congratulations. I do want to report, we do have a current long serving employee retiring, Craig Myers is retired and has been with our Highway Department for 34 years. His official retire day is November 15<sup>th</sup>, we wish him well. We expect to have a new mechanic already on the agenda for board approval next meeting which would put us at full staffing town wide for the first time in over a year.
