Supervisor Koetzle called the meeting to order at 7:00 PM;

## Town Council Reports:

Councilman Godlewski – "I would just like to mention the closing of Oliver's Café. The owners are retiring, the last day of business is going to be August 29<sup>th</sup>. I want to express my thanks for many, many good breakfasts over the years. When we first moved to Glenville, it wasn't the reason we moved to Glenville but it was kind of one of those things mentioned as an after thought after we bought our house "we will be a little closer to Oliver's". It really is a fantastic place, always warm and inviting. Sad to see it go but happy for all the memories. I wish them well."

Councilman Martin – "Our planner Mike Burns is retiring. Mike has done a great job for the department. It is just indicative of the overall staff, the quality of service that we get. I just want to pause at this time and recognize Mike and all of our employees for the fine work that they do. Mike has done a lot of good work, brought literally millions of dollars to this community with the grants he has written and administered. He spent many nights at Planning meetings, Zoning Board of Appeal meetings. That is tough work and he has done a good job. I just want to recognize him for his effort and all of our employees, again, for the fine work hey do and the fine service they provide."

Councilman Aragosa – "I'll echo those sentiments; Mike was a good guy to work with. I worked with him on the Environmental Conservation Committee quite a bit. I met with the Oktoberfest Committee last week. Gina and Vicki Hillis were there and Sgt. Green. It was a good meeting. Obviously we have a lot to do get this thing up and running for, I believe it is the 21st of September?"

Supervisor Koetzle – "The 25th."

Presentation – Corey Curran, intern through the Cornell Asset Management Program (CAMP), collected road inventory, survey conditions and collected culvert inventory and surveys through a training program through the Local Roads Program.

## Privilege of the floor:

Tom Coppola – "Corey's work ethics were unbelievable, he was fantastic. We really appreciate everything he did. We would like to keep him but obviously we can't. He did an unbelievable job on this program. I just want to say thank you, Corey. We appreciate your hard work and everything you did."

# Supervisor's Comments:

Supervisor Koetzle shared the following information:

 The first half of Metroplex sales tax revenue has come in − it is up 34% over last year's COVID totals.

- Cable franchise fee continues to fall. For the first half of 2021 it was \$171,000 or 4% below the first half of 2020.
- We are still waiting the release of next year's retirement rates. These are typically released in late August.
- On-line payments for water bills were popular 691 residents used this during this collection period
- Alplaus sidewalk project we are waiting for the county to deliver the engineering report, we are hoping to get that soon. The other two (2) projects are moving forward. The Scotia-Glenville one is done, Burnt Hills is ready to get into the ground. This is the only one that is kind of lagging behind everybody else.
- We met with the engineers today on our riverfront pedestrian trail. We secured a grant after many years of going after the grant. It should be in the ground by this fall.
- The 2020 census which has been released and has mixed results for us. The Village of Scotia lost nearly 500 residents from the 2021 census. That brought our totals down town-wide. The town outside the Village by 300 residents. We are now at 29,326 people.

Supervisor Koetzle moved ahead with the agenda.
