"STATE OF THE TOWN PRESENTATION"

Good evening. Thank you for attending the 8th Annual State of the Town. This has always provided a great opportunity for us to share with you the Town Board's priority for the coming year and for you to become more engaged in our shared work together.

As I have indicated before, this town has seen great change in the past 8 to 10 years and I believe that change has been positive: over the years we've focused on economic development to expand our tax base and have invested in our commercial corridors, in our neighborhoods and our parks; we have stabilized our finances and built a solid foundation that have led to manageable levy adjustments; and we have instituted technology and efficiency measures to lower the overall cost of government while protecting and enhancing your services.

Accomplishments:

Finance:

- We cut our debt by \$9 million or 40% since 2009 when we carried \$23 million in debt; today just \$14 million.
- We worked to protect the fund balance by reducing allocated funds from \$1.4 million in 2010 to just \$465,000 in the 2017 budget. That's a reduction of \$865,000 or 65%.
- We decreased our operational costs by reducing our wages by nearly 9% since 2008 despite seeing an increase of over \$1 million or a 47% increase in our health insurance line alone. We have one of the leanest staffs in the area with a cost per capita to the taxpayer of just \$86 (or \$2.2 Million) for general employees compared to Niskayuna of \$245 per capita at over \$5.4 million. For police, we it's \$74 per capita at \$1.7 million compared to Rotterdam at \$120 per capita at \$3.5 million.
- We created Capital Improvement Reserve Account and a Debt Reduction Reserve Account to allow for better long-term planning.
- We always stayed under the tax cap with average annual levy adjustments of about \$39.58 in five years or about \$7 per year which is roughly 8% over 5 years; about 1.6% each year.

Economic and Community Development:

- We attracted nearly \$165 million in new investments to this town in the past 7 years. This means we grew our tax base by \$46 million for total growth of nearly 2.5%. That represents about \$1.4 million of new money that is going to the county, your school districts and the town.
- Among the new projects we welcomed this year, was the town's first hotel
- We continued the process of rewriting the Comp Plan and began the difficult work of drafting specifics.
- Completed the water line on Sunnyside; attracting \$1.7 million.

- Made significant progress in cleaning up contamination on Freemans Bridge by demolishing the blighted Kenco Building and protecting residents and businesses from contamination.
- Finally secured the cleanup of the old GSA building
- Completed the Town Center investments of \$1.5 million; leading to nearly \$8 million in private improvements.
- Paved 17 miles of our neighborhoods: 3 years and \$1 million in paving and drainage work done. Scotchbush is next.
- Opened a new Dog Park and expanded Maalwyck Park, rehabbed and invested in Girls' softball fields at Indian Meadows, finally paved IM Park.
- Secured grants for the senior center expansion, FBR study, protection of the water supply and Biz and Technology Park.
- Held Community focus groups to better facilitate conversations between residents and the town.
- We began the implementation of technology: we committed to purchasing a new phone system that dates back to the early-90's and a new software package that will better connect our departments and help us operate more efficiently. All told we made a \$242,000 investment in technological upgrades.
- We implemented a new structure in the police department that will re-open the window to the public during normal business hours that was closed when dispatch moved to the county.
- Hosted another successful community event: Octoberfest...welcomed over 10,000 people.

In short, we streamlined operations to lower the cost of government, we made important investments in our community to enhance services, we expanded the tax base to lower your share of the levy, we slashed our debt to provide relief to the operational budget, we protected our fund balance to prepare us for capital needs, and all of this has led to a strong, vibrant, and sustainable community.

Goals:

 - Water meters: begin the implementation of automatic read meters to boost efficiency and lower costs for all water users.

- Senior Center expansion
- o Trial via Mekeel
- Fitness Park. YMCA partnership. Two "anchors" in Andersen and IM, by the Y.
- Dog Park improvements: shade structure, benches, pavilions.

Continue building our commercial corridors and protecting our neighborhoods by

 - I am proposing a joint resident committee called the Town and Village Joint Visioning Committee to identify, pursue and implement ideas where the town and village can better share resources to enhance services and reduce costs.
 - o Get Glenville Moving
 - Glenville History, Culture and Events Committee It's a brand new committee that will be charged to coordinate, plan, and implement town-wide initiatives to protect, promote and celebrate Glenville's historic, cultural and natural resources through special events, education and interpretation. The Committee will also be tasked with assisting the Town Board with understanding the town's assets and formulating a strategic plan that will help us better connect residents to them. This plan will include, but not be limited to, planning and implementing special events that highlight the town's history and culture, assisting the town historian with interpretation and preservation and in celebrating the town's culture. This committee will begin the work of preparing for the town's bi-centennial celebration in 2020.
- Perhaps our biggest challenge: Casino
 - Fair Share Impact Money
 - \$2.5 million to county (each year)
 - \$2.5 million to city (each year)
 - Zero to town
 - Police Impact
 - Traffic Impact
 - Business Corridor Impact
 - If state fails to act, the county can use the money to help town taxpayers by using the impact money for impact services such as dispatch services or sheriff services.
 - Sales Tax Fair Share: of \$1 million in sales tax, the county only shares \$8,000 with the town. The county takes \$745,000 (74.5%), the city gets \$130,000 (13%), Metroplex gets \$87,000 (8.7%) and the town gets .8%....So the county and city get \$5 million a year in impact money and 98% of the sales tax revenue. We get nothing from this. This project may help the county and city, but it has left the towns behind.
 - Not like this in many counties: Saratoga County shares sales tax 50/50 with its towns. Clifton Park with 3,000 more people gets over \$12million...we get \$2.7 million.

The Town is strong: our fund balance is healthy, levy rates are fat, and we have made significant investments in a community that are worthy of our town. We must not forget how we got here: prudent financial decisions, paying as we go, and finding creative ways to cut costs while protecting services.

I am happy to report that we continue on the path we started on eight years ago and because of that I am confident that we will meet our challenges, we will continue to expand our tax base, we will improve our community and together we'll make Glenville an even better place to call home.

WHEREAS Section 39 of the General Municipal Law of the State of New York requires municipalities to adopt a comprehensive investment policy; and

BE IT RESOLVED that the Town Board of the Town of Glenville hereby updates the Town's "Investment Policy":

INVESTMENT POLICY TOWN OF GLENVILLE

I. SCOPE

This investment policy applies to all moneys and other financial resources available for investment on its own behalf or on behalf of any other entity or individual.

II. OBJECTIVES

The primary objectives of the local government's investment activities are, in priority order,

to conform with all applicable federal, state and other legal requirements (legal);

to adequately safeguard principal (safety);

to provide sufficient liquidity to meet all operating requirements (liquidity); and

to obtain a reasonable rate of return (yield).

III. DELEGATION OF AUTHORITY

The Town Board's responsibility for administration of the investment program is delegated to the Supervisor who shall establish written procedures for the operation of the investment program consistent with these investment guidelines. Such procedures shall include an adequate internal control structure to provide a satisfactory level of accountability based on a data base or records incorporating description and amounts of investments, transaction dates, and other relevant information and regulate the activities of subordinate employees.

IV. PRUDENCE

All participants in the investment process shall seek to act responsibly as custodians of the public trust and shall avoid any transaction that might impair public confidence in the Town of Glenville to govern effectively. Investments shall be made with judgment and care, under circumstances then prevailing, which persons of prudence, discretion and intelligence exercise in the management of their own affairs, not for speculation, but for investment, considering the safety of the principal as well as the probable income to be derived.

All participants involved in the investment process shall refrain from personal business activity that could conflict with proper execution of the investment program, or which could impair their ability to make impartial investment decisions.

V. DIVERSIFICATION

It is the policy of the Town of Glenville to diversify its deposits and investments by financial institution, by investment instrument, and by maturity scheduling.

VI. INTERNAL CONTROLS

It is the policy of the Town of Glenville for all moneys collected by any officer or employee of the government to transfer those funds to the Supervisor within three (3) days of deposit, or within the time period specified in law, whichever is shorter.

The Supervisor is responsible for establishing and maintaining an internal control structure to provide reasonable, but not absolute, assurance that deposits and investments are safeguarded against loss from unauthorized use or disposition, that transactions are executed in accordance with management's authorization and recorded properly, and are managed in compliance with applicable laws and regulations.

VII. DESIGNATION OF DEPOSITARIES

The banks and trust companies authorized for the deposit of moneys up to the maximum amounts are:

VIII. COLLATERALIZING OF DEPOSITS

In accordance with the provisions of General Municipal Law § 10, all deposits of the Town of Glenville, including certificates of deposit and special time deposits, in excess of the amount insured under the provisions of the Federal Deposit Insurance Act shall be secured:

1. By a pledge of "eligible securities" with an aggregate "market value" as provided by GML § 10, equal to the aggregate amount of deposits from the categories designated in Appendix A to the policy.

2. By an eligible "letter of credit" issued by a qualified bank other than the bank with the deposits in favor of the government for a term not to exceed 90 days with an aggregate value equal to 140% of the aggregate amount of deposits and the agreed upon interest, if any. A qualified bank is one whose commercial paper and other unsecured short-term debt obligations are rated in one of the three highest rating categories by at least one nationally recognized statistical rating organization or by a bank that is in compliance with applicable federal minimum risk-based capital requirements.

3. By an eligible surety bond payable to the government for an amount at least equal to 100% of the aggregate amount of deposits and the agreed upon interest, if any, executed by an insurance company authorized to do business in New York State, whose claims-paying ability is rated in the highest rating category by at least two nationally recognized statistical rating organizations.

4. By an "irrevocable letter of credit" issued in favor of the government by a federal home loan bank whose commercial paper and other unsecured short-term debt obligations are rated in the highest rating category by at least one nationally recognized statistical rating organization, for the payment of 100% of the aggregate amount of public deposits and investments from the government and agreed-upon interest, if any.

IX. SAFEKEEPING AND COLLATERALIZATION

Eligible securities used for collateralizing deposits shall be held by a third party bank or trust company subject to security and custodial agreements.

The security agreement shall provide that eligible securities are being pledged to secure local government deposits together with agreed upon interest, if any, and any costs or expenses arising out of the collection of such deposits upon default. It shall also provide the conditions under which the securities may be sold, presented for payment, substituted or released and the events which will enable the local government to exercise its rights against the pledged securities. In the event that the securities are not registered or inscribed in the name of the local government, such securities shall be delivered in a form suitable for transfer or with an assignment in blank to the Town of Glenville or its custodial bank.

The custodial agreement shall provide that securities held by the bank or trust company, or agent of and custodian for, the local government, will be kept separate and apart from the general assets of the custodial bank or trust company and will not, in any circumstances, be commingled with or become part of the backing for any other deposit or other liabilities. The agreement should also describe that the custodian shall confirm the receipt, substitution or release of the securities. The agreement shall provide for the frequency of revaluation of eligible securities and for the substitution of securities when a change in the rating of a security may cause ineligibility. Such agreement shall include all provisions necessary to provide the local government a perfected interest in the securities.

X. PERMITTED INVESTMENTS

As authorized by General Municipal Law § 11, the Town of Glenville authorizes the Supervisor to invest moneys not required for immediate expenditure for terms not to exceed its projected cash flow needs in the following types of investments:

Special time deposit accounts.

Certificates of deposit.

Obligations of the United States of America;

Obligations guaranteed by agencies of the United States of America where the payment of principal and interest are guaranteed by the United States of America.

Obligations of the State of New York.

Obligations issued pursuant to LFL § 24.00 or 25.00 (with approval of the State Comptroller) by any municipality, school district or district corporation other than the Town of Glenville.

Obligations of public authorities, public housing authorities, urban renewal agencies and industrial development agencies where the general State statutes governing such entities or whose specific enabling legislation authorizes such investments.

Certificates of Participation (COPs) issued pursuant to GML § 109-b.

Obligations of this local government, but only with any moneys in a reserve fund established pursuant to GML §§ 6-c, 6-d, 6-e, 6-g, 6-h, 6-j, 6-k, 6-l, 6-m, or 6-n.

All investment obligations shall be payable or redeemable at the option of the Town of Glenville within such times as the proceeds will be needed to meet expenditures for purposes for which the moneys were provided and, in the case of obligations purchased with the proceeds of bonds or notes, shall be payable or redeemable at the option of the Town of Glenville within two years of the date of purchase.

XI. AUTHORIZED FINANCIAL INSTITUTIONS AND DEALERS

The Town of Glenville shall maintain a list of financial institutions and dealers approved for investment purposes and establish appropriate limits to the amount of investments which can be made with each financial institution or dealer. All financial institutions with which the local government conducts business must be credit worthy. Banks shall provide their most recent Consolidated Report of Condition (Call Report) at the request of the Town of Glenville. Security dealers not affiliated with a bank shall be required to be classified as reporting dealers affiliated with the New York Federal Reserve Bank, as primary dealers. The Supervisor is responsible for evaluating the financial position and maintaining a listing of proposed depositaries, trading partners and custodians. Such listing shall be evaluated at least annually.

XII. PURCHASE OF INVESTMENTS

The Supervisor is authorized to contract for the purchase of investments:

1. Directly, including through a repurchase agreement, from an authorized trading partner.

2. By participation in a cooperative investment program with another authorized governmental entity pursuant to Article 5G of the General Municipal Law where such program meets all the requirements set forth in the Office of the State Comptroller Opinion No. 88-46, and the specific program has been authorized by the governing board.

3. By utilizing an ongoing investment program with an authorized trading partner pursuant to a contract authorized by the governing board.

All purchased obligations, unless registered or inscribed in the name of the local government, shall be purchased through, delivered to and held in the custody of a bank or trust company. Such obligations shall be purchased, sold or presented for redemption or payment by such bank or trust company only in accordance with prior written authorization from the officer authorized to make the investment. All such transactions shall be confirmed in writing to the Town of Glenville by the bank or trust company. Any obligation held in the custody of a bank or trust company shall be held pursuant to a written custodial agreement as described in General Municipal Law § 10.

The custodial agreement shall provide that securities held by the bank or trust company, as agent of and custodian for, the local government, will be kept separate and apart from the general assets of the custodial bank or trust company and will not, in any circumstances, be commingled with or become part of the backing for any other deposit or other liabilities. The agreement shall describe how the custodian shall confirm the receipt and release of the securities. Such agreement shall include all provisions necessary to provide the local government a perfected interest in the securities.

XIII. REPURCHASE AGREEMENTS

Repurchase agreements are authorized subject to the following restrictions:

All repurchase agreements must be entered into subject to a Master Repurchase Agreement.

Trading partners are limited to banks or trust companies authorized to do business in New York State and primary reporting dealers.

Obligations shall be limited to obligations of the United States of America and obligations guaranteed by agencies of the United States of America.

No substitution of securities will be allowed.

The custodian shall be a party other than the trading partner.

APPENDIX A

Schedule of Eligible Securities

(i) Obligations issued, or fully insured or guaranteed as to the payment of principal and interest, by the United States of America, an agency thereof or a United States government sponsored corporation.

(ii) Obligations issued or fully guaranteed by the International Bank for Reconstruction and Development, the InterAmerican Development Bank, the Asian Development Bank, and the African Development Bank.

(iii) Obligations partially insured or guaranteed by any agency of the United

States of America, at a proportion of the Market Value of the obligation that represents the amount of the insurance or guaranty.

(iv) Obligations issued or fully insured or guaranteed by the State of New York, obligations issued by a municipal corporation, school district or district corporation of such State or obligations of any public benefit corporation which under a specific State statute may be accepted as security for deposit of public moneys.

(v) Obligations issued by states (other than the State of New York) of the United States rated in one of the three highest rating categories by at least one nationally recognized statistical rating organization.

(vi) Obligations of Puerto Rico rated in one of the three highest rating categories by at least one nationally recognized statistical rating organization.

(vii) Obligations of counties, cities and other governmental entities of a state other than the State of New York having the power to levy taxes that are backed by the full faith and credit of such governmental entity and rated in one of the three highest rating categories by at least one nationally recognized statistical rating organization.

(viii) Obligations of domestic corporations rated in one of the two highest rating categories by at least one nationally recognized statistical rating organization.
