MEETING OF THE TOWN BOARD TOWN OF GLENVILLE OCTOBER 3, 2018 AT THE GLENVILLE MUNICIPAL CENTER 18 GLENRIDGE ROAD, GLENVILLE, NEW YORK

Supervisor Koetzle called the meeting to order at 7:00 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Town Council Reports:

Councilman Godlewski – "I just want to thank everybody that helped out with Oktoberfest. That was last Saturday, it came off tremendously. It's really, in my opinion, developed into a regional event at this point, it's fantastic. I want to thank Vicki Hillis, the highway department and the police department."

Councilwoman Wierzbowski – "I too had a fantastic time at Oktoberfest and would echo Councilman Godlewski's comments. I also attended the Glenville Town Chiefs Association meeting last Thursday evening. They are still looking at options for the property on Vley Road for a possible training center location. So they are still doing some homework with that."

Councilman Aragosa – "The Oktoberfest was a great event. I had a lot of fun and was there quite a bit on Thursday and Friday. I hope they invite me back next year."

No one wished to exercise the privilege of the floor.

Supervisor's Comments

Supervisor Koetzle shared the following information.

The budget was filed last week with the Town Clerk. The overall highlights of the budget essentially is we are under our state mandated tax cap which we have been each year since it was instituted. The overall tax rate increase is 2.37% proposed in this budget which is again below the levy on the cap. We are reducing the combined A B & D fund balance appropriations by \$20,000 from \$360,000 to \$340,000 between 2018 and 2019 and we are reducing the overall debt by \$811,000. Both of those, just to note, are far less than I originally would have liked but because of the needs of the budget unfortunately we had to allocate more fund balance this year than I would have liked and we are now reducing the debt load to the level I would like. This reduction of \$811,000 will bring us to a reduction of 10 million dollars over nine year and that's still very impressive. So we should all be proud of that. This will have an increase to a typical village home around \$2.00 increase and outside the village for any town homeowner of \$19.00 increase for all funds, including special districts for that town resident, in 2019. In the Town General Fund, the A Fund, we are reducing the allocation of fund balance by \$10,000. We are going to keep our court revenues flat at \$195,000. In 2017 we collected \$213,000, this year we are on pace to end at about \$197,000 so I think it is prudent to keep it at \$195,000. We will increase our mortgage tax revenue by \$40,000, from \$540,000 to \$580,000. In 2017 we collected \$594,000 and for 2018 we are on pace for \$600,000. We have no CSEA Contract at this point for 2019 so there are no CSEA raises in the A Fund and as such there are no raises, as we always follow with CSEA for management, nonreps, appointed, elected all get the CSEA Contract so there is no raise for any of those

folks either. Once the CSEA Contract is reached all of those people I just named except for elected can have their salaries adjusted appropriately. Elected, once this budget is adopted, cannot go back and raise their salary. All elected would go a year without a raise. UCC expense increases by 2%, from \$761,000 to \$776,000. We have no expected retirements in the A Fund, which has been helpful. We did increase the deputy town clerk's hours from 20 to 25. It wasn't what was requested but it's a start in the right direction. We did include in this budget one new year round part-time park's laborer. We also included funding for parks which included replacement of floodlights, electric panel at Indian Meadows Ice Rink, purchase of a zero turn mower, paving the rest of Indian Meadows baseball parking lot and softball parking lot and installing four security cameras between Indian Meadows and Maalwyck Park. We have increased the Yates Mansion funding from \$50,000 to \$72,000 with increased funding for Thursdays In The Park from We started funding Glenville 2020 Celebration with a \$15,000 \$2,000 to \$2,500. allocation. In the B Fund, we did not use any fund balance so will maintain zero allocation of fund balance in the B Fund. We are increasing our building inspection fees, they have been busy from \$122,000 to \$130,000, in the 2019 budget. This is the fund that takes the police contractual, wage increases, and the new police officers we had for both 2018 and 2019 and that is a \$200,000 impact to the B Fund. That is a lot of what is driving our tax rate right now. We do have expected retirements of at least three people in the B Fund and we have a potential for another three to retire that we believe will not retire. But this budget includes using \$100,000 in retirement reserve fund. This does include a raise for the police chief of \$4,000, it also includes one marked police car, and one marked police truck and one other police car. It also includes two full-time and one part-time employee in the building department. That's not new employees, that's taking them out of three fulltimes and going to two full-time and one part-time as we discussed there might be a retirement there soon in that office. It also allows for purchasing a new vehicle for town use between the building department and the assessor's office. It includes \$30,000 for the planning and grant administration contract that we talked about earlier. The highway fund we are reducing our fund balance appropriation by \$10,000 from \$195,000 to \$185,000. There is an appropriation of \$50,000, again this is another way of appropriating out of a reserve fund, so we are appropriating \$50,000 out of the capital reserve fund to augment our paving program and our total budget for paving in this budget is \$348,000. There are no highway raises either since there is no contract for highway at the end of 2019 same story as with CSEA. There is a retirement in highway, I believe, this includes a payout for that. It includes a new full-time laborer in the highway, it increases the equipment line, and it includes the purchase of a new leaf machine and a new pickup truck. We also increased our brush and tree line a little bit from \$39,000 to \$60,000 for tree trimming and removal. Basically that's driven off the DEC tree inventory that they did. They identified critical trees in the town and some of those trees are on town property so there is probably going to be more tree trimming. We increased salt expense by \$10,000 this year from \$200,000 to \$210,000. We do have a likely retirement in the sewer fund and the payout is budgeted there and we have a possible retirement in the water fund with payout budgeted there also. The capital expenses overall this budget calls for a BAN that would fund four things. a street sweeper of \$220,000, a roadside mower of \$130,000, a remote mower of \$50,000 and parks we would finally finish the Maalwyck Park improvements by building a pavilion, restore the restrooms and the concession stand, bring water, sewer and electricity to the pavilion, build a playground and build an education and cultural display regarding archeology work that we are doing there. Even with that BAN we still reduce our debt level line. That's the highlights. As you know we will be calling for a public hearing on October 17th and we will have the public hearing on November 7th."

Councilwoman Wierzbowski – "Thank you for your hard work on this budget, also to Jason Cuthbert our Comptroller and the department heads who worked timely on their submissions and who were able to compromise where compromise was needed. I'm sure that it's not easy to do that and I appreciate that everybody works together to try and put a good budget together. You mentioned the increase in paving, is that going to increase our CHIPS fund that we are going to receive?"

Supervisor Koetzle – "No, so the CHIPS funds that we anticipate, of course we won't know until the budget is done for 2019, but we anticipate that we will get the same. That's why we took the \$50,000 out of the capital reserve in highway to add a little bit more but we don't anticipate any additional CHIP money."

Councilman Aragosa – "I just want to say that I'm glad to see that Maalwyck Park pavilion and finishing that project are in there. I spent a lot of days sitting in the park when my kids were younger, playing soccer, it would be nice to see that done."

Discussion...

Supervisor Koetzle – "I gave each one of you a map as to what has been worked out between National Grid, the property owners and the Town at this corner of Route 50 and Glenridge Road. This is a multi-year discussion that is finally coming to a

point to where people are comfortable. So if you look at the red line on the map in front of the First National Bank of Scotia that is the current line going down Route 50, it crosses Glenridge and over to the other side of Glenridge. Everything in red would be eliminated and you would take a right hand turn between the Glenville Queen Diner and the First National Bank of Scotia that would be underground between those two. It would then come back up and because of costs if we wanted to keep it under ground as it takes a left hand turn out to Glenridge in between the bank and the post office, that cost was prohibitive, they would have to do a manhole and a bunch of other things. So they will come back up at that point, overhead between the bank and the post office out to Glenridge Road. They have identified, and the bank has agreed to eliminating the maples that are there, which is actually breaking my heart because they are beautiful trees but the bank has talked about planting some that National Grid would accept to try to shield the post office because that is not the most beautiful property that we have in Town Center. So that is the map and plan of the actual project. There are two letters because \$82,393.00 of this project would be actually place through National Grid on the electric bill of every rate payer in the Town. The other letter is \$41,779.47 and that actually started as a \$91,000 charge to the Town and I was able to negotiate a \$49,000 credit with National Grid. The argument to the Public Service Commission was that these poles went up without the town's knowledge, without any input from the town and so I believe National Grid has to put some skin in this game because although by rights they don't have to talk to the community I think they should and Grid conceded with a \$49,933.00 credit. I couldn't get the \$50,000. Of the \$41,779.47 the First National Bank of Scotia is going to split that with the Town. So their board has authorized sharing that expense. So we have gotten our \$91,000 down to about \$20,000 to make this project happen. additional, we are still waiting on, is a contract with Spectrum and that would potentially be as high as a potential \$20,000 split over the bank and the town. So our total project exposure would be \$21,000, which is budgeted in the 2018 budget in the READY Fund."

Councilwoman Wierzbowski – "So the \$82,293.00 that would be spread over all of the rate payers in the town is that a onetime charge to their bill?"

Supervisor Koetzle – "Well we can request anything we want so we will have to talk about that when we get to what we want to do. We will have to do the math on that."

It was just an extraordinary event from start to finish and as Councilman Godlewski said it is a regional event and I am just so proud that Glenville kind of shines. I talk to people coming in, they are coming from Catskill, from the Hudson Valley area, from Lake George and they said this is the best Oktoberfest in the entire area. Most family friendly, most to offer and so we are very proud of that and what we have been able to build here in Glenville. Thank you to the 130 volunteers that made it all happen.

Lastly I want to at least get on your radar and get you thinking about it before the work session next week on October 10th. Things are moving and we talked about it during the budget forums, fairly quickly on our capital needs. Seems as though there is a lot of interest by a lot of folks that want to come and help us do what we want to do with building a new facility. There will be potentially three, there are three PUD's related to a new facility and some other mixed use stuff going on at three different areas in town. There's also the fourth option, still always, of staying where we are and doing what we want to do on this property. What I would like to do next week, and I have talked with our comptroller about this extensively, is I don't believe that there is anyone here, myself included, or anyone on staff that has the expertise to really evaluate for the town these particular proposals. I've been talking with a firm that does this kind of stuff that will evaluate the pros and cons of each proposal that will do all of the cost analysis, what makes sense and what doesn't make sense. So I want to bring that up but I also want to bring everyone up to date on the different proposals. One of them is already out there, going nowhere very fast, but it is out there and there are others coming in. We have to start evaluating where we want to be and I think this firm will help us do that. I think it is well worth the investment in having them do the research and present what the best option is. So that is for next week's work session."

Councilwoman Wierzbowski — "I like the idea of an independent entity evaluating proposals. I think it creates a layer of transparency that we recognize that it is a big decision for the town no matter how you look at it. I'm certainly not qualified to make that decision on my own."

Supervisor Koetzle – "I will tell you each and every one of them have their pros and have their cons. It's not going to be an easy decision."
