MEETING OF THE TOWN BOARD TOWN OF GLENVILLE DECEMBER 19, 2018 AT THE GLENVILLE MUNICIPAL CENTER 18 GLENRIDGE ROAD, GLENVILLE, NEW YORK

Supervisor Koetzle called the meeting to order at 7:00 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Also present were Michael Cuevas, Attorney for the Town and Jason Cuthbert, Comptroller and Vicki Hillis, Director of Human Services

Town Council Reports:

Councilman Godlewski – "Yes, Mr. Supervisor, I had an opportunity to share this with you yesterday. With respect to the Yates Mansion you and I have talked and I have reached out to our County Clerk, John Woodward, seeking information on the history of the Yates Mansion. I received a package in the mail, here at town hall, essentially with a chain of title and deeds going back to 1858. There is some cool stuff in here particularly the deed transfer from 1858, it's handwritten. It is a photocopy of the handwritten document. He enclosed a letter wishing us well with what he calls a worthwhile project and pointed us in the direction of Albany County. Prior to the 1850's when Schenectady County was incorporated they would be our keeper of records. I did reach out to a friend I have on the Town of Colonie Board who gave me a contact with the Albany County Clerk's Office so I will reach out to them in the next couple of days. I would like to give these documents to you tonight."

Supervisor Koetzle – "Thank you, I do appreciate the work you have done on that and I do agree it is a worthwhile project, thank you."

Councilwoman Wierzbowski – "I would like to wish the other board members and everyone here in attendance this evening a very Merry Christmas. It has been a pleasure to work with all of you this year."

Councilman Aragosa – "The Highway Department is still working hard on the leaf pickup. They will continue as long as there is no snow. Monday night I had a meeting with the Glenville Environmental Conservation Commission. They are working hard on the solar regulations for ground mounted solar and they are also looking into this Wolf Hollow Bike Trail project."

Supervisor Koetzle – "We are here tonight to honor and recognize the great work of the Burnt Hills/Ballston Lake 2018 Boys Varsity Cross Country Team. You guys had a great season. I know a few among you have had some highlights winning the New York State Class B Championship on November 10th. You guys had a great season, we have a proclamation that we are going to hand out to each of you."

(The proclamations were handed out and a photo was taken of the team and the Town Board members.)

No one wished to exercise the privilege of the floor.

Supervisor Koetzle shared the following information:

It is tax season and the town will have the tax bills out by the end of the year. This is the first year that we actually brought the function of printing and doing all of the bills in house. We used to do it through a third party vendor. First of all we had issues

with that third party vendor the past couple of times and so we decided to bring it in house and use our talent. Not only did we do it cheaper, more efficient, quicker and we had a lot more control over the process, but our bills will actually be out in the mail on time for the first time in a couple of years. I think a kudos to our assessor, our receiver, our comptroller for all working together to get this done. I have been told that Glenville has become the model and that now Scotia and a few other municipalities are going to copy what we did because it is cheaper and more efficient.

The next meeting will be on January 2nd, organizational meeting. That's where we appoint our committees and have all those resolutions.

I have a copy it was provided to me, of the Alplaus Hamlet Plan which is a draft that was done by the ARA (Alplaus Residents Association). I have been working with the ARA on this. There are a variety of things in the plan. It isn't official yet. They do go over things like pedestrian safety, speed along Alplaus Avenue and Bruce Drive, poor road conditions and drainage issues, connectivity with bike/walking path to the rest of Glenville, Scotia and the bike path, improvements to property and other issues within the Hamlet. So once this is final it will be delivered to the Board. Obviously we have to make sure it meshes with our comprehensive plan. It is formalized but informal vision of the Hamlet for the town to consider as we go forward with what we are doing.

As we get to the end of the year our books stay open for a couple more months as we clean up, we have bills to pay and things like that. Generally speaking, Jason reports that we should be running the surplus in our general and outside the Village both the A & B funds at about or just below \$50,000 in each potentially. We are running a deficit in the highway D Fund at about \$120,000 this year which is significant. Most of that is a project on Stottle Lane that we have gotten into that is... unfortunately the drainage is starting to collapse and the road is collapsing along with it so like most projects you get into the further you get into it the deeper it goes. It really needs a complete rebuild and that is a \$100,000 price which is going to leave us in a deficit in that fund which means we will be dipping into fund balance.

You all saw the Glenville/Glenfield debacle. I feel badly, I just wanted to publicly that I feel badly that DOT was somewhat embarrassed by that. That was never the intent of calling attention to it or trying to have fun with that. DOT I think in the end appreciated that there was a mistake. There was a sign placed on Route 5, coming in from Amsterdam to Glenville. I just want to take this opportunity to really point out the phenomenal response of DOT. I never in my wildest imagination did I think I would get a call from the Assistant Commissioner on a Sunday morning apologizing and having the sign removed on that very Sunday morning after they had just saw it on Saturday on Facebook. That was great work by DOT and I think it should be acknowledged.

Our Chairman of the Local Development Committee (LDC) is here tonight. He provided a copy of his report to each of us.

Dick Usas, Chairman of the LDC - "I will be stepping down as chairman in 2019 and taking the role as treasurer.

The support we have gotten from the board over the past five years has been tremendous. We started out with \$565,000 and we lent out the whole amount, it is gone. The good news is the payments that are coming back have now accumulated almost \$170,000. This grows at about a rate of \$7,000 a month. There are opportunities there for people like yourselves that are thinking about a business in Glenville, if your uncle has a business and he needs new equipment anything along those lines please talk to us."

Supervisor Koetzle – "The CFA's were awarded. We did receive a CFA for \$280,000 for a truck. We did not get funded for some of the really important projects that we wanted, one is the bike trail which is just astonishing to me and the Maalwyck Park."

Supervisor Koetzle moved ahead with the agenda items.

BE IT HEREBY FURTHER RESOLVED that the Town Clerk, on behalf of this Town Board, be and he hereby is authorized and directed to notify said Officer Greene of the aforementioned appointment.

Supervisor Koetzle – "The next two resolutions deal with the solar projects that are happening within the Town in partnership with the County. I know we have someone here from GE tonight. These are just calling for public hearings but if you are prepared for it maybe you could present the Board an update and take some questions on the project."

Kim Cupicha, GE Solar – "I am just here to give you an update on two of the projects that are going through for the Schenectady County Consortium. We are working with several different HGs in the area to basically build several solar sites throughout the County of Schenectady. There are two projects, after working through about twenty two different sites in the County that are still active and viable for the Glenville area. So those two sites, one is the Glenville landfill on 156 Barhydt Road and the other site is on the Van Buren Road Pump House Road. So you have done site

surveys, we are going through the Planning Board process and just basically getting through all of the site diligence to make sure these sites are still viable from a build ability standpoint. We are at a point now where we are starting to take feedback from National Grid which will obviously provide us with updates as to how much it would cost for us to interconnect the sites. So once we know all of that, in probably about a month or so, I will come back to you guys and let you know what your potentially key rate will be, what your lease rate and everything like that. So I just wanted to give you a high level update where we are with the projects and to answer question that anyone would have at this point."

Supervisor Koetzle – "So right now from our prospective the Planning Board has looked at this and gave it a preliminary site approval. We had a work session last week where our Town Attorney had mentioned to us that we would really need to exempt ourselves from at least one of the projects, actually both projects."

Michael Cuevas, Attorney for the Town – "In the case of the Barhydt Road site even though it is a landfill it's within the rural residential/agricultural district, which under our current solar laws they are not permitted there. So by exempting this project from the zoning law which a municipality can do, but in order to do it is recommended by the Department of State and case law that we do a balancing of public interest and that is why we have the public hearing to give the public the opportunity to weigh in on whether they too feel it is in the public interest and there are probably a lot of good reasons why this board could make that finding since it is a community solar project but we need to hear from the residents. On the other site that zoning would permit large scale solar projects. The issue there is that it would require a conditional use permit so we would be exempting this project from the requirement of going through the That would only complete the site plan review conditional use permit process. processes for these two sites and then we will be clear to go, assuming this board makes the finding after the public hearing that it is in the public interest that we exempt the project from our zoning law."

Supervisor Koetzle – "So for a time line are we are setting these public hearing for January 2nd. We could theoretically act that night if there wasn't really much public concern over it. It it's not too difficult for you we would probably be moving it to the January 16th for the passing of that resolution. You had requested I sign something from NYSERDA, is that a problem?"

Kim Cupicha – "We should be able to do that in January. I would prefer you follow you procedures. However we need to lock in the incentives as soon as possible."

Supervisor Koetzle – "We could have the resolutions ready on the 2nd and if there wasn't anything controversial we would probably act on it at that time. If we have a problem we may have to move it to the 16th.
