# "ORGANIZATIONAL" MEETING OF THE TOWN BOARD TOWN OF GLENVILLE JANUARY 2, 2019 AT THE GLENVILLE MUNICIPAL CENTER 18 GLENRIDGE ROAD, GLENVILLE, NEW YORK

Supervisor Koetzle called the meeting to order at 7:00 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Supervisor Koetzle – "Opens the public hearing to hear all persons interested in commenting on whether the Town Board should find that the GE Solar proposal to construct a Community Solar Project as part of the Schenectady County Solar Consortium on a 24-acre portion of the Town's 73 acre landfill site, located at 156 Barhydt Road, Glenville, NY is in the public interest and therefore exempt from the provisions of Chapter 270, Article XXII – Solar Energy of the Code of the Town of Glenville."

Supervisor Koetzle opened the public hearing at 7:04 PM.

Kim Cupicha, GE Solar – "I am here to talk about the two projects that we are looking to do in the Town of Glenville. The first one is the site on Pump House Road and Van Buren Lane. That is a 1.5 kilowatt dc solar project that is a community solar project that will be owned by GE. The way the system works is we basically install the system on the town property and then the town is benefitting from a discounted energy rate over time. We are in the process right now of getting the interconnection costs back from National Grid and once we have that information we will be able to tell the town exactly how much money they will be saving. This is the first project of the two that are in Glenville, we have other projects that are in Niskayuna, Rotterdam and Schenectady County as well. We originally started with twenty-two projects and now we are down to nine, all in Schenectady County. (Drawings were available to look at) The landfill site is on 156 Barhydt Road. It is a 5.9 kilowatt dc system located in the Town of Glenville. We are building the solar ground mount system completely on top of the cap, meaning that we will not be disturbing anything below the cap. We would be installing concrete blocks on top of the cap that basically keep us from disturbing anything. Both of those systems we are looking to start building most likely this summer."

Supervisor Koetzle – "I should be clear to, I guess when I read the resolution I didn't really explain exactly what we are here to determine and that is if this is in the public interest and therefore exempt from our zoning. That is what this public hearing is to focus on that these two projects would be exempt from zoning which currently they are not allowed in the zone that they are being proposed in."

Lou DiGesare, 46 Edmel Road – "I've lived there forty-six years and a resident all of my life. I think the projects are great ideas. The only concern I had is with the panel themselves and how they are going to be disposed of fifty years from now. I went on line and I just asked a simple question, the question was how much it costs to dispose of a panel from the system. Not one definite answer of what it is going to cost to get rid of these. They may have toxic waste in them. There is a problem with disposing of these and as of 2016 there was like 217,000 tons of this material that had been put into waste dump lands and tried to get rid of. In 2030 to 2040 that is going to run into about 70 million tons to get rid of. I'm wondering what is going to happen, another PVC thing in fifty years with these panels. I don't know, I have no idea and I don't have an axe to grind against the solar panels at all. I do have an article here that appeared in Forbes magazine on May 23rd of this year and the gentleman wrote this article is not a right wing wacko or anything like that, I checked that this morning. He does push atomic energy but he has some things to say about the panels that might be interesting for you to read. I made some extra copies for anyone that would like to read his article. What is the problem going to be with getting rid of the panels? General Electric might be fine with removing the panels but what are we looking at, are we going to contribute to something in the future that is going to be a big problem. I just don't know but I wanted to bring it to your attention."

Supervisor Koetzle – "You make some good points and if those are issues that we can work through as a Board, we have talked to our Town Attorney about some of these

issues an there are some ideas that we have. To the question of the public hearing tonight is if we find this to be in the public interest and we exempt it from zoning do you have comments on that in particular?"

Mr. DiGesare – "No, the property is there and if they are doing the right thing, hey it is free energy, well nothing is free."

Todd Benjamin - owner of property across the street from the land on Pump House Road – "I don't know if my questions are related to the zoning specifically but I certainly want to talk about the project that is under consideration. I think it is very unfair of the Board to ask members to come and talk about the project when we haven't had a chance to see the layout, the drawings, anything at all about the project. They were here and they are gone. I think it is appropriate for the Board to give the residents a chance to look at what is proposed. The second question is the Pump House Road has a proposal I believe the Board knows, or the Board should know that there was a proposal to raise the elevation of Pump House Road. So that proposal needs to be tied in with this proposal. Certainly when you are doing a new facility on a road and you are going to raise the road everything needs to be tied together. It simply can't be one item and then a second item because they do meet. There is a lot of traffic on that road, there is a lot of traffic for my business on that road although it is seasonal it is very busy for six months of the year. In addition, the elevation of the road has some concerns to me for adding a project on the road. That road, Pump House Road, floods frequently and the Board even knows or should know this past winter there was three or four feet of water along that road, covering the road. It makes access to the businesses down there and the pump house very difficult if not impossible. The Board should understand that the elevation of the road and the panels could be impacted by the water. I know that solar panels and water are a difficult combination. Without shutoff switches, without systems that are 100% protective and I'm talking 100% protective we would be creating a very serious situation. We don't know what the river level will go to. I know in my brief history of the thirteen or fourteen years down there there's been at least four to six feet of water on Pump House Road. The property where I think you are proposing it, although I can't see the drawings and I don't know where you are proposing it, is lower than the road. So I can imagine there being ten to fifteen feet of water in the area where they are planning these panels, maybe not, I haven't seen the drawing. In addition I haven't seen any site plans for trees or what it's going to look like. I personally like solar panels, I have them on my house but they need to get sunshine, they need to have the trees trimmed and cut back and there are a good number of trees along that road that provide stabilization for the roadway itself. If you cut the trees down to let the sunlight in for the panels what is going to happen to the road. I think there are a lot of situations there, as an engineer it will be designed properly, I'm sure but the Board needs to oversee that to make sure whatever is proposed will work. Maybe not zoning issues but certainly a concern for me. So the road level, the proposal for changing the road level, taking the trees off the roadway stabilization, flooding concerns and how do you guarantee that you are not going to flood whatever panels you put in there."

Supervisor Koetzle – "I appreciate what you are saying in the comments that you have. The Town Board's role, this will go through site plan review through the Planning Board. Our consideration is unfortunately for tonight and why you don't have rendering probably ready for you is because that is being handled through the Planning Board and we can get those for you quick enough but our consideration is really only about exempting it from zoning if we find it to be a public interest or not. All the other, the flooding, the road, all of that will be taken care of under the Planning Board review so...

Mr. Benjamin – "When can you get the drawings to me?"

Supervisor Koetzle –"I'll have to get them from Planning and we can email them to you. I apologize, we should have had them here tonight but our consideration is if it should be exempt from zoning."

Michael Cuevas, Attorney for the Town – "On the zoning question, just to be clear that site that you are talking about is highway/commercial zone and solar arrays are permitted in highway/commercial. The only thing is that under present town solar energy law they have a ten acre limit. This site wouldn't be ten acres it's less than that, its 5.8 acres so that is not a problem. The only issue is it would have to go through a conditional use process, that's the only difference. Otherwise this project would just go through a regular zoning process. It doesn't need an exemption for the use, it wouldn't need a use variance...

Bill Boulton, 436 Wagner Road – "I am totally unfamiliar with the Pump House Road, I am totally unfamiliar with the project, I've never been on Pump House Road. We, I believe as citizens are being asked if we support you making the decision as a town to give this project exemption when we don't really know what the project is. All we know is solar panels, GE, two locations, so I can give you my tentative feelings on it but until I know what is being planned it is hard for me to commit to you, to make a decision on how I feel as a neighboring property to this proposal without knowing... you could imagine from one end to another how big or small this could be imagined. Now she was gracious enough to show me some of her plans and the maps and I'm sure she has maps and you could take a look at the Pump House Road proposal. I would be myself and two of the other gentlemen that are here tonight are probably the closest neighboring properties to the landfill site which is the only property I'm speaking on. We are the only properties that can see that landfill from our properties. I am totally in favor of solar, I think it is a great idea, it is a great use of property that would otherwise be very difficult to do anything with. Again depending on the height and scope of this I can't even see this being visible from 890. I think they would be totally covered by the tree line that comes up in front of the landfill. I think this is a great addition to the town if this is kept within a reasonable scope as to what I understand is going to happen. As one of the larger properties bordering this property, I am totally in favor of it, tentatively. As we go forward I would like to get some more information. It is a great idea and I am really happy that the town is going forward with this.

James Zielinski, 152 Barhydt Road — "I boarder this project. I am just a little concerned with this on the landfill with circuitry and overheating may be a fire hazard. I don't think it is the greatest idea on top of a landfill. I don't think anything is a good idea on top of a landfill. There is all kinds of combustible debris underneath it. I'm very concerned with that aspect and also when I have coffee in the morning I'm looking out my kitchen window I'm going to be staring at all of these panels. I'm concerned with the border overlying, fencing what is going to be done with that existing fence that is there now is basically shot, there are chunks missing, it's fallen in, trees are over grown through it. The entrance in the front of my home is just a basic fence with an old run down rusted town garage of which I don't know if you use it for storing or what. I do live there, the esthetics on a daily basis has a big effect on someone's overall emotional or visual capability. I would like to see a little more on it but overall the idea is a lot better than the gun club."

No one else wished to speak; Supervisor Koetzle closed the public hearing at 7:25 PM

Supervisor Koetzle – "Opens the public hearing to hear all persons interested in commenting on whether the Town Board should find that the GE Solar proposal to construct a Community Solar Project as part of the Schenectady County Solar Consortium on about a 4 acre portion of the Town's 5.84 acre vacant land site, located at Van Buren Lane and Pump House Road, Glenville, NY is in the public interest and therefore exempt from the provisions of Chapter 270, Article XXII – Solar Energy of the Code of the Town of Glenville."

Supervisor Koetzle opened the public hearing at 7:26 PM

Michael Cuevas, Attorney for the Town – "Hearing some of the comments I feel we could respond a little bit. The proposal has been in the works for more than one year. Starting with Schenectady County's formation of a county wide solar consortium. There were presentations before the County Legislature when they first came up with the concept of the consortium trying to meet the states objective as far as solar energy over the next decade or so. Parcels were identified and once the number of parcels around the county were identified the county had a public hearing on this. I'm not quite sure that people study the legal notices that carefully but in order to do their due-diligence under the State Environmental Quality Review Act they did have a public hearing going site by site through that at the county level. GE did make a presentation to this town board at a work session, two presentations to the Planning and Zoning Commission and is scheduled for a public hearing at the next Planning and Zoning Commission. At the last public meeting of the Planning and Zoning Commission at the request of the board members, GE did present some photographs as far as the potential views from different points around the sites and committed to having certain trees remain on the properties to shield the view of the solar arrays from as many important viewpoints as possible so that, I think somebody mentioned with respect to the Van Buren Lane site, those trees along the road would remain in place, the ones that would shield it from view from 890 would be in place. Obviously there are a lot of scrub type trees on the property that would be removed and the same as far as the capped landfill site that on the cap there's vegetation growth there and that would be removed and basically just have southern facing the array. The remaining trees on that site would not be disturbed. They have certain viewpoints around that site too that show there would be relativity little visual in that. This is also subject to approval my NYS Department of Environmental Conservation that regulates landfill closures and once a landfill is closed, monitoring so if there was any danger to the public DEC would certainly well know about that. From my research siting solar on landfills is one of the most popular places around the country that municipalities are siting landfills because basically there is nothing else they could do with that land. We do have a conceptual agreement with General Electric so GE Solar would be responsible for the maintenance of the site, they would be responsible at the end of the life for decommissioning the site and during the life they would be responsible for the security, fencing and so forth to make sure the site is secure. I hope this answers the questions but there are other documents available both from the county and that we have received from GE that can be shared anybody if they are really interested."

No one else wished to speak; Supervisor Koetzle closed the public hearing at 7:30 PM

## **RESOLUTION NO. 7-2019**

WHEREAS Section 39 of the General Municipal Law of the State of New York requires municipalities to adopt a comprehensive investment policy; and

**BE IT RESOLVED** that the Town Board of the Town of Glenville hereby updates the Town's "Investment Policy":

# INVESTMENT POLICY TOWN OF GLENVILLE

#### I. SCOPE

This investment policy applies to all moneys and other financial resources available for investment on its own behalf or on behalf of any other entity or individual.

## II. OBJECTIVES

The primary objectives of the local government's investment activities are, in priority order,

to conform with all applicable federal, state and other legal requirements (legal);

to adequately safeguard principal (safety);

to provide sufficient liquidity to meet all operating requirements (liquidity);

to obtain a reasonable rate of return (yield).

## III. DELEGATION OF AUTHORITY

The Town Board's responsibility for administration of the investment program is delegated to the Supervisor who shall establish written procedures for the operation of the investment program consistent with these investment guidelines. Such procedures shall include an adequate internal control structure to provide a satisfactory level of accountability based on a data base or records incorporating description and amounts of investments, transaction dates, and other relevant information and regulate the activities of subordinate employees.

## IV. PRUDENCE

All participants in the investment process shall seek to act responsibly as custodians of the public trust and shall avoid any transaction that might impair public confidence in the Town of Glenville to govern effectively. Investments shall be made with judgment and care, under circumstances then prevailing, which persons of prudence, discretion and intelligence exercise in the management of their own affairs, not for speculation, but for investment, considering the safety of the principal as well as the probable income to be derived.

All participants involved in the investment process shall refrain from personal business activity that could conflict with proper execution of the investment program, or which could impair their ability to make impartial investment decisions.

#### V. DIVERSIFICATION

It is the policy of the Town of Glenville to diversify its deposits and investments by financial institution, by investment instrument, and by maturity scheduling.

#### VI. INTERNAL CONTROLS

It is the policy of the Town of Glenville for all moneys collected by any officer or employee of the government to transfer those funds to the Supervisor within three (3) days of deposit, or within the time period specified in law, whichever is shorter.

The Supervisor is responsible for establishing and maintaining an internal control structure to provide reasonable, but not absolute, assurance that deposits and investments are safeguarded against loss from unauthorized use or disposition, that transactions are executed in accordance with management's authorization and recorded properly, and are managed in compliance with applicable laws and regulations.

## VII. DESIGNATION OF DEPOSITARIES

## VIII. COLLATERALIZING OF DEPOSITS

In accordance with the provisions of General Municipal Law § 10, all deposits of the Town of Glenville, including certificates of deposit and special time deposits, in excess of the amount insured under the provisions of the Federal Deposit Insurance Act shall be secured:

- 1. By a pledge of "eligible securities" with an aggregate "market value" as provided by GML § 10, equal to the aggregate amount of deposits from the categories designated in Appendix A to the policy.
- 2. By an eligible "letter of credit" issued by a qualified bank other than the bank with the deposits in favor of the government for a term not to exceed 90 days with an aggregate value equal to 140% of the aggregate amount of deposits and the agreed upon interest, if any. A qualified bank is one whose commercial paper and other unsecured short-term debt obligations are rated in one of the three highest rating categories by at least one nationally recognized statistical rating organization or by a bank that is in compliance with applicable federal minimum risk-based capital requirements.
- 3. By an eligible surety bond payable to the government for an amount at least equal to 100% of the aggregate amount of deposits and the agreed upon interest, if any, executed by an insurance company authorized to do business in New York State, whose claims-paying ability is rated in the highest rating category by at least two nationally recognized statistical rating organizations.
- 4. By an "irrevocable letter of credit" issued in favor of the government by a federal home loan bank whose commercial paper and other unsecured short-term debt obligations are rated in the highest rating category by at least one nationally recognized

statistical rating organization, for the payment of 100% of the aggregate amount of public deposits and investments from the government and agreed-upon interest, if any.

#### IX. SAFEKEEPING AND COLLATERALIZATION

Eligible securities used for collateralizing deposits shall be held by a third party bank or trust company subject to security and custodial agreements.

The security agreement shall provide that eligible securities are being pledged to secure local government deposits together with agreed upon interest, if any, and any costs or expenses arising out of the collection of such deposits upon default. It shall also provide the conditions under which the securities may be sold, presented for payment, substituted or released and the events which will enable the local government to exercise its rights against the pledged securities. In the event that the securities are not registered or inscribed in the name of the local government, such securities shall be delivered in a form suitable for transfer or with an assignment in blank to the Town of Glenville or its custodial bank.

The custodial agreement shall provide that securities held by the bank or trust company, or agent of and custodian for, the local government, will be kept separate and apart from the general assets of the custodial bank or trust company and will not, in any circumstances, be commingled with or become part of the backing for any other deposit or other liabilities. The agreement should also describe that the custodian shall confirm the receipt, substitution or release of the securities. The agreement shall provide for the frequency of revaluation of eligible securities and for the substitution of securities when a change in the rating of a security may cause ineligibility. Such agreement shall include all provisions necessary to provide the local government a perfected interest in the securities.

#### X. PERMITTED INVESTMENTS

As authorized by General Municipal Law § 11, the Town of Glenville authorizes the Supervisor to invest moneys not required for immediate expenditure for terms not to exceed its projected cash flow needs in the following types of investments:

Special time deposit accounts.

Certificates of deposit.

Obligations of the United States of America;

Obligations guaranteed by agencies of the United States of America where the payment of principal and interest are guaranteed by the United States of America.

Obligations of the State of New York.

Obligations issued pursuant to LFL § 24.00 or 25.00 (with approval of the State Comptroller) by any municipality, school district or district corporation other than the Town of Glenville.

Obligations of public authorities, public housing authorities, urban renewal agencies and industrial development agencies where the general State statutes governing such entities or whose specific enabling legislation authorizes such investments.

Certificates of Participation (COPs) issued pursuant to GML § 109-b.

Obligations of this local government, but only with any moneys in a reserve fund established pursuant to GML §§ 6-c, 6-d, 6-e, 6-g, 6-h, 6-j, 6-k, 6-l, 6-m, or 6-n.

All investment obligations shall be payable or redeemable at the option of the Town of Glenville within such times as the proceeds will be needed to meet expenditures for purposes for which the moneys were provided and, in the case of obligations purchased with the proceeds of bonds or notes, shall be payable or redeemable at the option of the Town of Glenville within two years of the date of purchase.

#### XI. AUTHORIZED FINANCIAL INSTITUTIONS AND DEALERS

The Town of Glenville shall maintain a list of financial institutions and dealers approved for investment purposes and establish appropriate limits to the amount of investments which can be made with each financial institution or dealer. All financial institutions with which the local government conducts business must be credit worthy. Banks shall provide their most recent Consolidated Report of Condition (Call Report) at the request of the Town of Glenville. Security dealers not affiliated with a bank shall be required to be classified as reporting dealers affiliated with the New York Federal Reserve Bank, as primary dealers. The Supervisor is responsible for evaluating the financial position and maintaining a listing of proposed depositaries, trading partners and custodians. Such listing shall be evaluated at least annually.

#### XII. PURCHASE OF INVESTMENTS

The Supervisor is authorized to contract for the purchase of investments:

- 1. Directly, including through a repurchase agreement, from an authorized trading partner.
- 2. By participation in a cooperative investment program with another authorized governmental entity pursuant to Article 5G of the General Municipal Law where such program meets all the requirements set forth in the Office of the State Comptroller Opinion No. 88-46, and the specific program has been authorized by the governing board.
- 3. By utilizing an ongoing investment program with an authorized trading partner pursuant to a contract authorized by the governing board.

All purchased obligations, unless registered or inscribed in the name of the local government, shall be purchased through, delivered to and held in the custody of a bank or trust company. Such obligations shall be purchased, sold or presented for redemption or payment by such bank or trust company only in accordance with prior written authorization from the officer authorized to make the investment. All such transactions shall be confirmed in writing to the Town of Glenville by the bank or trust company. Any obligation held in the custody of a bank or trust company shall be held pursuant to a written custodial agreement as described in General Municipal Law § 10.

The custodial agreement shall provide that securities held by the bank or trust company, as agent of and custodian for, the local government, will be kept separate and apart from the general assets of the custodial bank or trust company and will not, in any circumstances, be commingled with or become part of the backing for any other deposit or other liabilities. The agreement shall describe how the custodian shall confirm the receipt and release of the securities. Such agreement shall include all provisions necessary to provide the local government a perfected interest in the securities.

## XIII. REPURCHASE AGREEMENTS

Repurchase agreements are authorized subject to the following restrictions:

All repurchase agreements must be entered into subject to a Master Repurchase Agreement.

Trading partners are limited to banks or trust companies authorized to do business in New York State and primary reporting dealers.

Obligations shall be limited to obligations of the United States of America and obligations guaranteed by agencies of the United States of America.

No substitution of securities will be allowed.

The custodian shall be a party other than the trading partner.

## Schedule of Eligible Securities

- (i) Obligations issued, or fully insured or guaranteed as to the payment of principal and interest, by the United States of America, an agency thereof or a United States government sponsored corporation.
- (ii) Obligations issued or fully guaranteed by the International Bank for Reconstruction and Development, the InterAmerican Development Bank, the Asian Development Bank, and the African Development Bank.
- (iii) Obligations partially insured or guaranteed by any agency of the United States of America, at a proportion of the Market Value of the obligation that represents the amount of the insurance or guaranty.
- (iv) Obligations issued or fully insured or guaranteed by the State of New York, obligations issued by a municipal corporation, school district or district corporation of such State or obligations of any public benefit corporation which under a specific State statute may be accepted as security for deposit of public moneys.
- (v) Obligations issued by states (other than the State of New York) of the United States rated in one of the three highest rating categories by at least one nationally recognized statistical rating organization.
- (vi) Obligations of Puerto Rico rated in one of the three highest rating categories by at least one nationally recognized statistical rating organization.
- (vii) Obligations of counties, cities and other governmental entities of a state other than the State of New York having the power to levy taxes that are backed by the full faith and credit of such governmental entity and rated in one of the three highest rating categories by at least one nationally recognized statistical rating organization.
- (viii) Obligations of domestic corporations rated in one of the two highest rating categories by at least one nationally recognized statistical rating organization.
- (ix) Any mortgage related securities, as defined in the Securities Exchange Act of 1934, as amended, which may be purchased by banks under the limitations established by bank regulatory agencies.
- (x) Commercial paper and bankers' acceptances issued by a bank, other than the Bank, rated in the highest short term category by at least one nationally recognized statistical rating organization and having maturities of no longer than 60 days from the date they are pledged.
- (xi) Zero coupon obligations of the United States government marketed as "Treasury strips."

## Discussion...

Michael Cuevas, Attorney to the Town – "The term of the agreement will be a five (5) year term. The revisions with respect to compensation – 2% per year for each of the first four (4) years and the fifth year 21/4%. There are adjustments that the parties agreed to, particularly with the work week in the summer. Our summer session is for about five (5) months of the year so it is significant that we will be looking to shift to a rather than just four (4) days Monday -Thursday, a summer week, to have coverage Monday - Friday and that is accomplished by having half of the bargaining unit work ten (10) hour shifts Monday - Thursday and the other half working ten (10) hour shifts Tuesday – Friday. There are a number of minor adjustments that in the past have been subject to grievances or improper practices at PERB with respect to whether meal breaks are paid or not during overtime, what events the Commissioner of Public Works/Highway Superintendent call in members from other bargaining units to assist with work when there aren't sufficient numbers of people, particularly occurs during snowplow season but parties recognize it could occur at other times of the year as well. Controlling the compensatory time accumulations helps the town get more people at work, it doesn't cost any more or less it just means that more overtime would be paid out rather than accumulated as comp time and paid at some later date. Trying to get employees available at critical times, vacation block schedules have been adjusted. Adjustment to health insurance, rather than take one great leap sometimes working through those employees that contribute less than 15% to their health insurance premiums currently would, for each year for the five year contract pay an additional 1% each year until they get to 15%. Then there is a similar situation with the dental and vision coverage."

Councilman Aragosa – "I am glad to see that you guys all got together and got it done. Hopefully we can move forward with the other bargaining units and get those done before they are up."

Councilwoman Wierzbowski – "I would like to thank the town's negotiating team and also the negotiating leadership from CSEA Highway Union. I know that these things are sometimes contentious. I am pleased to see that everybody was able to get to the table and talk about terms and conditional and the fact that we have a contract basically prior to the expiration of your previous one is remarkable. Everybody who was involved in negotiations should be commended. I also want to say that I think this is a fair deal for the town. Thank you to everybody that was involved and I appreciate everything you do for the town, you work very hard even when people don't see you out and about. Thank you very much."

Supervisor Koetzle – "I just want to let you know how much I appreciate the relationship we had through the process. We were frank, open and honest. I really

appreciate the fact that you heard the things the town needed and you met us halfway, I think we met each other halfway. I think it was a very good process. I am proud of the fact that we have a contract before it expired, which I think is the first time anyone can remember that happening. I appreciate all of the work you guys put in to this and your willingness to listen to our concerns and meet us halfway. I think it is a fair, reasonable, affordable and I think in the long run it's going to be a very good contract for not just the employees but the Town of Glenville so thank you for all of your work on it to the entire team and all of your members."

**WHEREAS**, thereafter GE Solar identified the closed landfill portion of the Barhydt Road town parcel (about 25 acres) as a potential site, prepared a site plan which was reviewed by the Schenectady County Legislature pursuant to the State Environmental

Quality Review Act (SEQRA) which result in a Negative Declaration regarding potential significant environmental impacts; and

**WHEREAS**, the GE Solar site plan was reviewed by the Town of Glenville Planning and Zoning Commission and received preliminary site plan approval with conditions; and

WHEREAS, the Van Buren Lane site is currently zoned Rural Residential Agricultural which under the Town Solar Energy Law does not permit large scale solar energy projects, despite the fact that this site is a former landfill; and

**WHEREAS,** across the nation, former landfill sites are frequently chosen as sites for large scale solar energy production facilities due to the limitations on using the land for other purposes; and

WHEREAS, the Town Board of the Town of Glenville conducted a public hearing, pursuant to a public notice duly published, on January 2, 2019 at 7:00 PM at the Glenville Municipal Center at which time all persons wishing to be heard had an opportunity to address the Town Board on the governmental nature of the plans to develop a solar energy facility at the 156 Barhydt Road closed landfill site; and

**WHEREAS**, governmental entities, such as towns, villages, cities, counties and fire districts, are accorded only a limited immunity from, and may be subject to local land use regulations depending on the proposed use of property and application of a balancing test; and

**WHEREAS**, the Town Board considering the comments made at the public hearing, hereby
