MEETING OF THE TOWN BOARD TOWN OF GLENVILLE JUNE 19, 2019 AT THE GLENVILLE MUNICIPAL CENTER 18 GLENRIDGE ROAD, GLENVILLE, NEW YORK

Supervisor Koetzle called the meeting to order at 7:00 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Town Council Reports

Councilman Godlewski – "My thoughts and condolences to the former Schenectady Mayor Karen Johnson who passed away. Karen had a huge impact on our local community, she was a strong advocate for the arts and the community and my thoughts are with her family.

The Zoning Revision Committee met earlier in June. We continued our discussion in review of the zoning code. We talked about whether or not flag pole lots would be legal going forward in the Code. We also discussed what car dealerships would do with access inventory. I understand with the road closure, specifically with the development that is going on at the County Airport that that may be an issue for Mohawk Honda specifically."

Councilman Aragosa – "I had the opportunity to participate in the Flag Day Parade along with the Supervisor and Councilman Godlewski.

I talked with Tom Coppola today and their new sweeper in on the road and they are doing their best to get the roads cleaned."

Supervisor Koetzle – "Item No. 5 is a public hearing to hear all persons interested in the proposed local law to amend Section 88-7, "Seizure of dogs; redemption of dogs; impound fees" chapter of the Code of the Town of Glenville.

Supervisor Koetzle opened the public hearing at 7:05 PM; no one wished to speak; Supervisor Koetzle closed the public hearing at 7:06 PM.

Privilege of the Floor

The following people spoke during privilege of the floor.

Paul Brino, 298 Hoffmans Hill Road – Mr. Brino mentioned an article in the paper regarding a lot of people moving out of Duanesburg because they don't have high-speed internet. He also informed the board that part of Glenville especially the remote areas do not have high-speed internet. When he started hearing it he called Pattersonville Phone Company to tell them to the have to get on the grant, they were all excited. They got the grant. Spectrum/Time Warner at the time told us they had 100% coverage at the time across the river which was not true. Internet is everything, he doesn't get cable. He thinks it is a monopoly that they did it to Pattersonville so that they wouldn't bring it over there. Mr. Brino asked if there was anything that the board could do to assist him. He feels that we really need to push it. He stated that the Duanesburg Supervisor was able to get the grant to get the fibers upgraded in their township.

He also talked about the closure of Wolf Hollow Road. It is really not in bad shape. That is an outlet road all the way over to Rte. 147. It is a straight shot and everyone likes to come through it.

Supervisor Koetzle – "Sir, I don't want to interrupt you but Wolf Hollow is a county road, the county made the decision. I would strongly urge you to address the County Legislature on that because we brought these very things you are about to say. I want to let you know it is not a town decision. It's completely a county decision."

Mr. Brino – He was hoping that the town could put some pressure on them. At the end of the day there is going to be a fatality.

No one else wished to exercise the privilege of the floor.

Chief Janik – "Thank you to the Town Board. I really enjoyed the interview process. We had some really good candidates. One of the things that impressed me the most about Michelle is that she came right out and told us the Glenville was her only pick. Obviously on the Schenectady County Civil Service list you can be canvassed by multiple agencies and I believe she was. She said to me that Glenville was her only place because she lived here, raising a family here, her parents are from here and it made me very happy that she was dedicated to this department and this community. Thank you very much for

that.

She currently serves with the New York Army National Guard and holds the rank of 1st Lt, so she already has rank over a lot of people in the department. She started her military career in 2006 and she is stationed at 42nd Infantry Division in Troy, NY. Michelle is here tonight with her parents, her son Clark and her husband Valentine who is Deputy Sheriff of the Schenectady County Sheriff's Department.

Michelle Arreola was sworn in by Supervisor Koetzle.

Update on the Freemans Bridge Road Gateway Revitalization project by Creighton Manning Engineering.

A power point presentation was given showing a scope of the work, review some of the major design items, where are the impacts based on what the design was, the main jurisdiction of the design and also what funding opportunities are out there for this project.

Supervisor Koetzle shared the following information:

CSEA had a labor management meeting with Jason Cuthbert, Comptroller, Mike Cuevas and myself. It was a very good and productive meeting. The main agenda item on the meeting was how well the summer hours are working, since everybody wants to evaluate that. Clearly when you institute a new program there are going to be some bumps and some things along the way. The consensus from CSEA is that the summer hours are working very well. Jason ran an analysis to show that they were actually getting more work hours done in 2019 than we did in 2018 and 2017. Where we are starting to have some concerns with the workload is we did not have summer help this year in May. So we had to allocate more highway hours into parks in 2019 over 2018. Secondly the weather has had an effect on the workload, we have had a very wet spring. That has put us back on some projects. The third thing we have to deal with is the increase in demand services. Every year it seems like we are getting more and more calls and more and more services out there. Although hours worked has increased also requests for work has also increased.

Speaking on broadband in rural areas I had an opportunity as a member of the executive board of the Association of Towns to be part of the delegation going to DC the first week in June. We went to Washington to lobby our legislatures here from the capital region but also those on the committees for certain things. We spoke to them about broadband access in rural areas. There needs to be more money and more investments being put into broadband. The same can be said for here in NYS, there really is very little for all that has been done in the session this year down in Albany. Very little has been done. If anything at all infrastructure investments and particularly expanding broadband in rural areas. That is something we are asking our representatives to work on and secondly infrastructure money and if the feds are going to send infrastructure money to the states we ask they do not send it to Albany. Albany cannot be trusted with money coming from Washington. We know that if it goes to Albany it is going to end up either at the MTA or one of the bridges in NYC. We want the money to go directly to the communities and we want fare equal allocation between the communities so that every community gets something as opposed to some communities getting everything and many getting nothing.

An update on our open position in planning. In lieu of having a planner all of these weeks we have a contract with Barton Loguidice to help us with all of the work that is coming in. They do come in here and work out of our office. We ae on second interviews with the final candidates for that position. We had an interview today and another one on Friday and then hopefully we will have a decision shortly after that.

Last Saturday I attended a ground breaking at Oakhill School for a new

gymnasium. This gymnasium was very important for them. They had to try and get transportation to the YMCA previously. The population they deal with is very difficult. So this new gymnasium will give them the ability to have onsite structure for the kids that attend the school.

I had the opportunity today, to go down to Sacandaga School and sit with the parents to experience drop-off down there, which is chaos down there. This is the part of the town and the village that come together on Broad Street and Schermerhorn Street. Part of Broad Street is our and part of it is in the village but neither side has sidewalks. There were a lot of cars, a lot of kids all in the same area trying to get to school. I set up a meeting with the mayor and the superintendent in July. We are going to go out there with the police chiefs and look at what we can do. I think it is going to end up being a village issue, we only have three houses on Broad Street.

As you know the Dutch Meadows PUD is in front of the Glenville Environmental Conservation Committee (GECC) on June 24th, then onto the Planning Board and then before us, hopefully, by our August meeting.

Mohawk Honda is also progressing, just so you are aware and that's on track for a potential final approval on July 8th. I know there is a list of things they have to address.

I also met with the providers of the electric charging stations. Working with Vicki Hillis and Tom Coppola we have sited all of the spots in the park, all our properties where those chargers will go. We are moving slowly through the process. They should be here shortly and hopefully installed by the end of the summer.

I also received the draft report on the proposals for town hall options. The draft report has five (5) options. They narrowed it down to two (2) suggestions and one preferred option. They are asking for a little more time to finish up some more information before we have a work session on that. I am anticipating that potentially we could have a work session as early as July on it but probably more likely August.

In that line Barton and Loguidice is also working with DASNY on SAM grants and DASNY has indicated that they need to know what we are doing with our 1.5 million dollars. So, a decision one way or the other really has to come shortly and we have to keep moving on that.

Time Warner has had a problem with the franchise fee. We received many calls here at town hall. Your bill probably reflects it as every bill in town seems to have gotten an upcharge in their franchise fee. Mike and I have been in contact with Time Warner. Their government relations gentleman has indicated that they are now aware of the problem because we brought it to their attention. They are working on the problem. He did not elaborate what the problem was or promise that it wouldn't happen in next month's billing cycle but once they get it fixed they will go back and issue credits. If you get any calls on this it is a known problem, they are working on it and residents will get their credits.

Lastly just some financial news. Last week the state released new tax base growth factors for all municipalities. You all should be proud. Of course Glenville has the highest in the county. This is a measure of year over year growth in the local tax base. Ours was just under 1%. Doesn't sound like a lot but that represents twenty million dollars in new tax base in the Town of Glenville. The average in the county was .4% so we are more than double in growth. This tax base growth will add another \$85,000 in allowable tax base in the 2020 budget. Our year to date court revenues are up 15% from last year which is significant. We are on pace for our highest court revenue since 2013. If we could just get it a little bit higher we'll be at the highest since 2009.

Looking towards next year, because we will be in budget season soon, we will receive our preliminary 2020 health insurance costs already and these estimates for these premium increases will range probably between 5 to 6%. We face an increase of roughly a \$100,000 if these rates hold, in health care spending in the 2020 budget.

Lastly with eleven months left on the 2019 tax cap year we finish this year's virtually guaranteed to be the maximum 2% next year. So that will allow us an additional \$185,000 in new tax levy for 2020. We just talked about the health insurance taking \$100,000. I can guarantee you that the increases in the contractual increases in the raises are much more than \$85,000. So we are again going into 2020 with a higher burden cost then what our tax cap is going to allow."

Councilwoman Wierzbowski – "Going back to the Broad Ban Initiative, when I was working with Assemblywoman Walsh, there was a state initiative for municipalities who have blank spots in their broad ban coverage could apply. There was funding that was allocated and the municipality had to apply for it and manage it. I don't know if that initiative is still there but it might not be a bad idea to reach out to her office to see if they could check on it. I do know that Galway applied and was able to take advantage of that."

Supervisor Koetzle – "I will double check it, I think that it did not survive."

Councilman Pytlovany – "You said our court revenue was up, which is great. I think that it has a lot to do with us maintaining a full police department and adding one officer to our department last year and obviously adding another one tonight. I think that has an effect on our court revenue".

Supervisor Koetzle – "The Chief has reinstituted the traffic division. He has assigned an officer to the traffic car. That hasn't even taken effect with these numbers yet."

WHEREAS, this Town Board has held a public hearing with respect to the adoption of said Local Law on June 19, 2019 at 7:00 PM, at which time all parties in interest were afforded an opportunity to be heard and to publicly comment on said Local law, amending the Code of the Town of Glenville; and

WHEREAS, pursuant to Part 617 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act) ("SEQR"), the Town Board has determined that the adoption of the proposed Local Law does not constitute an action as defined and could be considered without regard to SEQR; and

WHEREAS, the Town Board of the Town of Glenville, after due deliberation, finds it in the best interest of the Town to adopt said Local Law,

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Glenville does hereby establish a Local Law to amend the Code of the Town of Glenville to adopt Local Law #3 of 2019, amending Section 88-7, entitled "Seizure of dogs; redemption of dogs; impound fees", as set forth below:

Local Law Number 3 of 2019

A local law amending the Code of the Town of Glenville Section 88-7. Seizure of dogs; redemption of dogs; impound fees

Be it enacted by the Town Board of the Town of Glenville as follows:

Section 1. Short Title and Applicability.

Updated Redemption of Dogs Fees and Impound Costs Act. This local law shall apply to the fees and costs charged to dog owners to redeem dogs seized and impounded in

the Town of Glenville.

Section 2. Declaration of Policy.

The costs of sheltering dogs which have been seized for violation of this Chapter, Chapter 195 of the Code of the Town of Glenville or Article 7 of the New York State Agriculture and Markets Law have increased dramatically since this section was last revised in 2010. The Town Board hereby declares it to be the policy of the Town that the individual dog owners should bear the cost of sheltering their dogs when those dogs are redeemed after seizure. Currently, the vast majority of the cost \$62 of the \$65 daily cost is borne by Town taxpayers. Assessing the cost of sheltering to the dog owners will promote compliance with the dog ordinance and dog safety.

Section 3. Section 88-7 "Seizure of Dogs; redemption of dogs; impound fees" of the Code of the Town of Glenville is amended to read as follows:

A. Any Dog Control Officer may seize any dog in the Town of Glenville:

- (1) Which is unlicensed or untagged, in violation of §§ 109 and/or 111 of the Agriculture and Markets Law.
- (2) Which is not leashed or under the control of its owner, in violation of § 88-1A(1) of this article or § 195-17 of Chapter 195 of this Code.
- B. Any dog seized pursuant to Subsection $\bf A$ of this section shall be impounded, fed, cared for or disposed of as provided in § 117 of the Agriculture and Markets Law.
- C. The owner of any dog impounded by the Town of Glenville shall be entitled to redeem that dog within five business days, excluding the day the dog is impounded, provided that the owner produces proof that the dog is licensed and can be identified as the dog licensed to the owner and pays a fee of \$50 for the first impoundment; \$75 for the second impoundment; and \$100 for a third or subsequent impoundment within 12 months of the first impoundment. In addition to the impoundment fee an additional fee equal to the total of all fees and/or costs that are chargeable to the Town under the terms of the Town's agreement with the Animal Protective Foundation for sheltering services relating to cases of impoundment shall apply in all cases.

Section 4. Severability.

If any provisions of this local law are held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, the remaining provisions of the local law shall remain in effect.

Section 5. Effective Date.

This local law shall take effect twenty (20) days after filing with the Secretary of State.

BE IT FURTHER RESOLVED that this resolution shall take effect twenty days after it is filed with the Secretary of State of the State of New York.
