Supervisor Koetzle called the meeting to order at 7:00 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Town Council Reports:

Councilman Godlewski – "People may have noticed the teal ribbons going up around parts of our town, parts of neighboring towns, Alplaus, Scotia and I've seen them in Ballston Spa and Niskayuna. Teal ribbons are symbolic of the town's teal movement which is to bring awareness of ovarian cancer. September is Ovarian Cancer Awareness Month.

My wife and I welcomed our first born child and wanted to extend a heartfelt thanks to the staff over at Bellevue Hospital. They were fantastic so anyone that is in that situation should consider Bellevue Hospital."

Supervisor Koetzle – "September is also Prostate Cancer Month as well. They are the blue ribbons. We actually know here some folks are dealing with that and so September is ovarian and prostate cancer awareness month."

Councilwoman Wierzbowski – "This weekend is the Alplaus Lady Auxiliary is their Apple Festival from 1:00 to 4:00 PM on Saturday. I attended the 75th Anniversary celebration for the Beukendaal Fire Department. It was a really lovely ceremony. They recognized three fifty year members and they were all women, which I though was absolutely amazing. Congratulations!"

Supervisor Koetzle – "The Dutch Fair is this Saturday."

Councilman Aragosa – "I was invited by Senator Tonko to go to an event on September 6th in Schenectady emphasizing the census and the importance of everybody being counted. The census people would love to come and do a presentation with us.

I'm still looking for help with the parking during Oktoberfest. Feel free to reach out to me."

Supervisor Koetzle – "Item number 5 is a public hearing to hear all persons regarding a proposed local law to amend Chapter 270, "Zoning" of the Code of the Town of Glenville to add a new section entitled "Freemans Bridge Road Overlay District and Design Standards". They include items such as canopies, drive thru, materials that can be used, architectural details, standards for a variety of different screening and service entrance locations, pedestrian conductivity, lighting, etc. We will be having this public hearing tonight, as many of you know we had public hearings at the last meeting as well on some of the zone change proposals on Freemans Bridge Road. With all of the confusion going on apparently on all the different things we are proposing for Freemans Bridge Road. Jim Martin and I, Jim is leading the effort on this through the Code Review Committee, will be meeting with Freemans Bridge Road land owners this Friday morning.

We will be presenting all of this, our Community Development Director Melissa will be with us as well. We will be presenting to them and really just soliciting back their comments and talking more about what we are proposing and more of what they are looking to do with Freemans Bridge Road."

It is important to me and I know it is important to the board that we hear from the residents and we talk about the issues facing the town. We don't sugarcoat things here. We put budgets together, try to put very strong budgets together and we have done that for ten (10) years. We are going to be very honest and frank about what is going on in the Town of Glenville. If anyone has any questions or comments as we go along please feel free to join in because I really want it to be more of a discussion then just a presentation."

No. 11 of the Town of Glenville be established to include real property described by section, block and lot number in the petition and consisting of one parcel located at 175 Haigh Road in the Town of Glenville; and

WHEREAS, a map and plan prepared by Brett L. Steenburgh, P.E. dated September 3, 2019 was filed as an addendum to the petition and depicts the extension as an addition of one service lateral to the water main in Haigh Road and the report of the applicant confirms that information;

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Glenville hereby adopts the following order:

ORDER

- 1. A petition to add an Extension to Water District No. 11 from an existing water line in the right of way of Haigh Road to 175 Haigh Road has been filed with the Town Clerk on or about August 12, 2019.
- 2. The real property to be included in the extension is described by section, block and lot number as identified on the Schenectady County Real Property Tax Service Agency Tax Map as: 29.5-2-50.1
- 3. The improvements proposed are the installation of a service lateral connection to the water main of approximately 100 feet for an individual service connection along the route described in "1" as indicated above.
- 4. The amount proposed to be expended for the extension is approximately \$2000.00 to be borne entirely by the developer.
- 5. No portion of the cost this extension will be attributable to Water District No. 11.
- 6. The estimated annual cost to the typical property is:
 - a. District: \$48.68
 - b. O & M: \$74.31
- 7. The requirement for a map, plan and report describing the extension has been met by the filing of the map and plan dated September 3, 2019 which describes the I lateral connection.
- 8. The proposed financing method to be employed in the construction of this connection in this Water district extension is private financing by the developer.

New Business

Councilman Godlewski – "I was just wondering, one I saw, Supervisor, the proposal as 9 million in capital requests is it 1.5 or 1.75 ...

Supervisor Koetzle - "1.75"

Councilman Godlewski – "Would it be possible to get a list of the proposed capital requests or numbers...

Supervisor Koetzle – "You will get that."

Councilman Godlewski – "The other thing I was curious about it was mentioned that the, Glen Oaks is currently on Village water. What is the process for that? Is that something we negotiate, is that something that we are entitled to, how does...

Supervisor Koetzle – "There are residents...as soon as we are able to bring infrastructure there they will become our customers. That as I am told is basically some sort of pumping pit and some other type of infrastructure that would have to be brought into Glen Oaks. Apparently whatever has happened in the past the town's infrastructure is within striking distance where in the past it has not been."

Councilman Godlewski – "The Dutch Meadows project was that property purchased, that mortgage fee going to the last budget cycle, was that an option, do we know?

Supervisor Koetzle – "I think it is private equity. I don't think they are financing it or are you talking about the people that move into it. Is that what you are talking about?"

Councilman Godlewski – "I was talking more about the purchase of the property."

Supervisor Koetzle – "They haven't closed yet. It is my understanding there is not necessarily going to be a mortgage."

Councilman Godlewski – "I thought, and I could be wrong, that there was a restoration on the winter paving money. I know things got a little fuzzy at the very end of the state budget process. Maybe it's something you could take a look at."

Supervisor Koetzle – "It is very fuzzy. Everybody has a different, even AIM is very fuzzy with this whole, well tell the comptroller to take it out of sales tax...So if you talk to the Governor he's going to tell you AIM is in your budget but the comptroller says no. We will look into it."

Councilwoman Wierzbowski - "I know that we are very shortly going to be

removing the house on Swaggertown Road that is part of the dog park property. I am going to be looking with you to start looking at our community garden because I think that was one of the stumbling blocks. Now is the time to start planning for next year."

Councilman Aragosa – "The event on Friday morning for the Freemans Bridge Road, were you able to reach out to them by email or...

Supervisor Koetzle – "They all got mailed invitations. It is at 9:00 AM on Friday at Mohawk Honda. We can accommodate as big of a crowd that comes. We will have a presentation and make sure everybody understands the proposal and solicit comments back.

Part of the presentation is going to be going through all of the work that has been done on Freemans Bridge Road over the years. There have been a significant amount of resources. We start back to the money we got from DEC to clean up the Kenco property, then you go back to the grants for Complete Streets and the grants for Waterfront Revitalization. There has been a lot of investment in Freemans Bridge Road over the years so now we are at a stage where we have to get the corridor ready for the 21st century. If we want to go to DOT now and say we have our studies done and now if we get this done now we have all of our ducks in a row and now we are ready to go to the TIP and get significant money for Complete Streets and the revitalization of Freemans Bridge Road. So this is a critical piece of that and that's what we are going to talk about."

Supervisor Koetzle asked for a motion to adjourn; motion to adjourn; Moved by Councilwoman Wierzbowski, Seconded by Councilman Aragosa, everyone being in favor the meeting was adjourned at 8:10 PM.
