MEETING OF THE TOWN BOARD TOWN OF GLENVILLE OCTOBER 2, 2019 AT THE GLENVILLE MUNICIPAL CENTER 18 GLENRIDGE ROAD, GLENVILLE, NEW YORK

Supervisor Koetzle called the meeting to order at 7:00 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Town Council Reports:

Councilman Godlewski – "I just want to extend my thanks to everybody that either participated in or volunteered time to the Glenville Oktoberfest. Unfortunately, I was not able to make it because I am finding out day by day that I am at the mercy of our new born. I heard it was a great event. I would also extend my condolences to the family of Judge Vincent Riley who passed away this last week. Like any lawyer coming up in Schenectady County you come through Judge Riley at some point in time. He was straight out of central casting for what a judge looked like. He will certainly be missed. He also was great with the mock trial here and in Schenectady County. I also want to extend a happy birthday to Supervisor Koetzle, who hit a milestone yesterday."

Councilwoman Wierzbowski – "I was at the Oktoberfest and I echo Councilman Godlewski's comments. Thank you to our staff and all of the volunteers committee and everybody that was involved. It was a beautiful day. This was the 10th annual and I remember when it started over at the Schenectady County Airport in a very small field and we worried about where we were going to park the cars and for several years it rained until we moved it to Maalwyck Park and it's been sunny pretty much ever since. I also attended the Alplaus Lady Auxiliary Apple fest. I also went up to Westfest for a little while. It's an annual gathering that is put on by residents of West Glenville. Happy Birthday, Mr. Supervisor."

Councilman Aragosa – "Thank you to everyone that was at Oktoberfest. Thank you to all those that helped me in the parking lot. Happy Birthday Mr. Supervisor."

Supervisor Koetzle – "Item number 5 is a public hearing regarding a petition for a proposed extension to Water District No. 11 to include property located at 175 Haigh Road."

Supervisor Koetzle opened the public hearing at 7:06 PM

No one wished to speak; Supervisor Koetzle closed the public hearing at

7:07 PM.

The following people spoke during privilege of the floor.

Kurt Semon, 181 Droms Rd – Mr. Semon teaches Civics & Government, US History, American Revolution and Military History at the BH/BL High School. He stated that he would consider running for the School Board but he can't, it is against the law. No person shall be a School Board member in a school district that employs them. He said that he could argue that he could function properly on the School Board simply by abstaining from voting on the teacher's contract, but no the law, known as an Ethics Law, is clear and designed to avoid even the appearance of a conflict of interest, real or

perceived.

He said that he was surprised to learn that Mr. Andrew Kohout is running for the Glenville Town Board in the upcoming election not because of qualification issues bur because of the clear violation of basic ethics. Mr. Kohout is the full time Village of Scotia Public Works Superintendent.

Mr. Kohout does not inspire public confidence when he desires a public office, meaning employment, in the Town that directly conflicts with the obligations and trust of his current Village office and employment.

He will encounter multiple serious conflicts of interest that would prevent him from serving the Town and Village whole heartedly at the same place.

Should Mr. Kohout find himself on the Town Board on January 1st, the spotlight will shine of the Trustees serving the Village of Scotia then they would have to terminate his employment on that same day. It would be sad however that we the people would have had to rely on an Ethics Law to encourage government employees to do the right thing.

Richard Usas, 1 Miracle Lane - He has lived in the town for the past eighteen (18) years and has been active in economic development for the town for the last ten (10) years. He has a concern regarding one of the candidates for the town board is also an employee of the Village of Scotia. He believes this presents a conflict of interest. Nothing could present a bigger conflict then being the commissioner and a Village employee and being responsible for decisions on the Glenville Town Board. He had been advised that the Village Code of Ethics states that no Village employee shall accept other employment that would impair his independence of judgement in his fiducial duties. He stated that nothing could present a bigger conflict than being a Village employee and also being responsible for decisions on the Glenville Town Board. Particularly since the town and the village have a number of municipal agreements. The position of being appointed the Scotia DPW Commissioner and Glenville Town Board are clearly incompatible as their interest will be divided. He believes that the Town Board and the Scotia Trustees needs to adjust this as a review of their ethics law. Glenville deserves a town board member who is connected 100% to the job and does not bring potential for conflicts and ethic concerns. He urged all town residents to make their voices heard that the town board and the village board implement an ethics law to avoid such conflicts.

Supervisor Koetzle shared the following information:

Oktoberfest was a fantastic success again. I want to thank Vicki and Jamie and Heather and the entire committee. I think we said it take about 250 volunteers to run the event. Thank you to our police department and highway department. Jim Valchovic and I were talking at the event when we started 10 years ago, we said that Glenville needs a community event. This is kind of what we envisioned and it came together. The work that the folks do to make it happen is just humbling. It celebrates Glenville while bringing in so many people from other areas to celebrate Glenville and that is what I think is very special. Thank you all for all your hard work on it.

I wanted to report back to the board, I know at the last board meeting Councilman Aragosa brought up in his report that there was some talk of the highway summer hour schedule, some might have liked it and some might have not. Jason and I took a look at the final totals of the summer hours now that we are through it If you all recall back at the negotiation table we all sat down and we said to the CSEA Union that there is one major issue here we have a department working four days when everybody else is working five days we want coverage on that fifth day. We want to make sure that residents are receiving services on every working day. So, we cashed that out, we came to the table a couple of times over with different ideas on how to make it work. I want to congratulate CSEA for working with us on that. I think it is a great partnership. I think the proof is really in the numbers now. The road crew worked an additional 84.6 hours per week on the roads during that period. We went from 8,500 hours worked in 2018 to 10,320 in 2019. We increased parks by 18.3 hours per week for a total of 403 hours. In the garage we saw 16.2 hours of additional work per week. In total there was 165 hours of additional work in the entire highway department in 2019 over 2018. Clearly our productivity increased under the new system. We did add part time park help that has helped a little bit. Next year there is going to be an enhancement in our agreement that kicks in next year. We are reducing the number of people off from six to five so those numbers are going to go up even more. Our work force needs to be congratulated because they embraced it and made it work.

The budget it out. I am sure we will have some It is budget time. discussions on it. This proposed 2020 proposed tax rate increase is 2.52% within the tax cap. This increase will hit a typical village home owner at about \$4.00 per year and a typical town home owner at about \$23.00 per year. This is another executive budget for us, a ten-year executive budget. It will reduce the debt load again for the town. We talked in the budget forums about how important is was to reduce the debt load from 23 million and we reduced it just about 12 million. We have also reduced the use of our savings account again in those three main funds which we have talked about in the past. When we inherit this budget, we will reduce it 1.4 million dollars in our savings account to pay for operational budget. We have reduced that down this year proposed \$40,000 and that will bring us to about \$300,000 total equalization in our savings account this year. That is a trend that is going opposite of other municipalities but it is important because it has helped us do so many things. This financial planning has produced concrete results that's why I think I'm committed and the other members of the board are committed to these principles because it has allowed us to do things like save the historic Yates Mansion, construct the new gun range for our police department, install street lights in our commercial corridors, sidewalks and pedestrian paths in our neighborhoods our commercial corridors, install new automatic read meters which brought efficiency to our operations, expand the Senior Center, replace DPW and Parks equipment building, construct Anderson Dog Park, improved our roads and our playing fields at Maalwyck Park and Indian Meadows. These are all things that we have been able to do because we stayed true the principles of protecting our savings account, reducing our debt and lowering our overall costs. So, as we go through the budget, I look forward to having spirited conversations, talk about ideas."

WHEREAS, the Town Board of the Town of Glenville (herein called the "Town Board" and "Town," respectively), in the County of Schenectady, New York, has received a written petition, dated August 12, 2019, pursuant to section 191 of the Town Law, for the extension of Water District No.11 (herein called "District") whose petition was signed by the owners of at least one-half (1/2) of the assessed valuation of all taxable real property situate in the proposed District and including the signatures of the parties under contract to purchase from the owner of at least one-half (1/2) of the assessed valuation of such taxable real property situate in the proposed District owned by seller/ owner, all as shown upon the latest completed assessment roll of said Town, and a map, plan and report for the extension of Water District No.11 of the Town of Glenville dated September 2, 2019 by Brett Steenberg, P.E. for a service lateral connection including land or rights in land, connections, fill, services, appurtenances and related site work (herein called the "Water Improvement") from the existing the water main in Haigh Road to the lands of the petitioner known as 175 Haigh Road, was prepared and is now on file in the office of the Town Clerk of the Town for public inspection; and

WHEREAS, pursuant to the Order duly adopted on <u>September 18, 2019</u>, the Town Board has determined to proceed with the establishment of the proposed extension to the District and adopted an Order reciting a description of the boundaries of the extension of the District in a manner sufficient to identify the lands included therein as in a deed of conveyance, the improvements proposed, the maximum amount proposed to be expended for the construction of the Water Improvement in the District, the proposed method of financing to be employed, the fact that a map, plan and report describing the same are on file in the Town Clerk's office for public inspection and specifying <u>October 2, 2019</u>, at 7:00 PM, as the time when, and the Glenville Municipal Center, 18 Glenridge Road, Glenville, New York, in the Town, as the place where, the Town Board would meet to consider the establishment of an extension of the District and to hear all person interested on the subject thereof concerning the same, and for such other action on the part of the Town Board in relation thereto, as may be required by Law ; and

WHEREAS, certified copies of such Order were duly published and posted pursuant to the provisions of the Town Law; and

WHEREAS, the Town Board has given due consideration to the impact that the proposed extension to the District may have on the environment and on the basis of such consideration, the Town Board has found that no substantial adverse environmental impact will be caused by the extension of the District; and

WHEREAS, the Town Board and the Town have complied in every respect with all applicable federal, state and local laws and regulations regarding environmental matters, including compliance with the New York State Environmental Quality Review Act, comprising article 8 of the Environmental Conservation Law and, in connection therewith, a duly processed Negative Declaration and/or other applicable documentation has been filed in the office of the Town Clerk; and

WHEREAS, a Public Hearing in the matter was duly held by the Town Board on said October 2, 2019, commencing at or about 7:00 PM, at the Glenville Municipal Center, 18 Glenridge Road, Glenville, New York, at which all interested persons desiring to be heard were heard, including those in favor of, and those opposed to, the proposed extension to the District.

NOW, THEREFORE, upon the evidence adduced at such public hearing

RESOLVED AND ORDERED by the Town Board of the Town of Glenville, in the County of Schenectady, New York as follows:

Section 1. It is hereby determined that:

- (a) The Notice of Public Hearing was published and posted as required by Law, and is otherwise sufficient;
- (b) All the property and property owners benefited included within the proposed extension to the District hereinabove referred to in the recitals hereof are benefited thereby;
- (c) All the property and property owners benefited are included within the limits of the proposed extension to the District; and
- (d) It is in the public interest to establish the extension to the District.

Section 2. The establishment of the proposed extension to the District is hereby approved, as hereinafter described, and said District shall be designated and known as Extension No. 49 to Water District 11 in the Town and shall include the property commonly known as 175 Haigh Road (S/B/L # 29.5-2-50.1).

Section 3. The Water Improvement is hereby authorized to be constructed in the District and the amount proposed to be expended therefor, including the expenses incurred in connection with the establishment of the extension to the District, is to be fully borne by the developer; the plan of financing is to be fully and completely borne by the developer, at no cost to the Town or other users in the District.

Section 4. The permission of the State Comptroller is not required with respect to the extension of the District because the cost of the extension to the typical property is not above the Average Estimated Cost to the Typical Properties for the establishment of similar types of districts as computed by the State Comptroller.

Section 5. The Town Clerk of the Town is hereby authorized and directed within ten days after the adoption of this Resolution and Order, to file certified copies thereof, in duplicate, in the office of the State Department of Audit and Control in Albany, New York, record same in the office of the Clerk of the County of Schenectady.

Section 6. This Resolution and Order shall take effect immediately.
