MEETING OF THE TOWN BOARD TOWN OF GLENVILLE SEPTEMBER 2, 2020 AT THE GLENVILLE MUNICIPAL CENTER 18 GLENRIDGE ROAD, GLENVILLE, NEW YORK

Supervisor Koetzle called the meeting to order at 7:00 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Town Council Reports:

Councilman Godlewski – "Resolution add on #3 was going to be part of my remarks under town council reports. I will state preliminarily that I am happy to see that we are addressing this issue and I will speak a little more about it when we come around to the resolution.

I want to comment on something I saw in our community recently that I thought was outstanding. I was checking out in Market 32 and observed a gentleman wearing an army cap clearly a veteran. A you man bagging groceries made it a point to go and acknowledge the veteran and thanked him for his service. It was just a great simple moment. The veteran actually thanked the young man for working at the grocery store during these times."

Councilwoman Wierzbowski – "I want to offer a public congratulations to Jim Jones of Scotia Fire Department and also the East Glenville Volunteer Fire Department. He was the recipient of the Schenectady County Fire Officer of the Year Award. I've known Jim for a number of years, both in his role as a firefighter with Scotia and with East Glenville."

Councilman Aragosa – "Schenectady Foundation along with the Scotia Masonic Lodge, the Village of Scotia and the Regional Food Pantry are planning a drive thru food pantry on September 22nd. Get in line early, the last one we had at the Crosstown Plaza ran out of food in forty-five (45) minutes.

Reminder that the deadline for the census is coming up rapidly, which is September 30th. The Town of Glenville at this point is about 75% complete. Go to www.my2020census.gov it takes less than 5 seconds to complete.

On Saturday I attended the Elks Club Golf Tournament. Happy to see our former colleague John Pytlovany there. It was a nice event.

I heard this week of the closing of the boat house over on Aqueduct Road."

Proclamations were presented to Sheryl Lauria for her volunteerism in the community from Senator Tedisco, Assemblywoman Walsh and Supervisor Koetzle.

No one wished to exercise the Privilege of the Floor.

Supervisor Koetzle moved ahead with the agenda.

Supervisor Koetzle – "Item No. 7 is a public hearing to hear all persons interested in the proposed local law to amend Article I, Section 242-14, "Re-subdivision" of the Code of the Town of Glenville.

Melissa Cherubino – "What we were trying to do, some come in and they want to do a lot line adjustment and it may actually implicate something that doesn't match our code. So rather then just letting people do that outside the Town Hall in attorney's office we wanted to have some sort of internal review to make sure that it doesn't create any kind of problems in terms of lot size requirements or sizing or if there is any kind of water bodies on it and that kind of stuff. So, it is really just creating a sketch plan or approval process internally in the planning office and we are coordinating it with the assessor. We brought it to the Code Committee and then to you."

Supervisor Koetzle opened the public hearing at 7:20 PM.

No one wished to speak; Supervisor Koetzle closed the public hearing at 7:21 PM.

Supervisor Koetzle - "Item No. 8 is a public hearing to hear all persons interested in the proposed local law to amend Article I, Sections 232-1, Sections 232-1 - 7, "Garbage and Refuse" of the Code of the Town of Glenville"

Melissa Cherubino – "The Garbage and Refuse changes have to do with shortening the time frame when the building department sends out a violation notice to someone and when we can either issue an order to go ahead and clean it up. It was five (5) days, it's now three (3) days. Also, that process of having Department of Public Works (DPW) authorizing doing some sort of clean up. We didn't have that actually listed in the code."

Supervisor Koetzle opened the public at 7:23 PM

Susan Booth-Binczik, 391 Green Corners Rd – "First I'd like to express appreciation for the fact that the proposed code changes were posted on the Town's website.

With respect to the proposed changes to the Garbage and Refuse law I see a problem that concerns me. It appears that the proposed changes with have the effect of prohibiting composting. I don't know if that was part of the intent, I certainly hope not. I hope the Board will reconsider the planned vote tonight and reword the law so that it doesn't end up with, I don't know how many hundreds of Glenville residents effectively being made into criminals. The definition of garbage in the Code includes anything that is capable of decay, that means any plant or animal material. The proposed change to Section 232-4c prohibits garbage for being stored on private property except in an enclosed building or a solid container. That means no compost piles. If this law is passed making any town resident with a compost pile subject to fines and jail time. I think you are going to have a lot of upset people. So, for the benefit of the residents who may be attending this meeting or subsequently reviewing the recording I request that somebody there explain you thought process on this issue and that the Board reconsider adopting these changes as written."

No one else wished to speak; Supervisor Koetzle closed the public hearing at 7:25 PM

Courtney Heinel, Legal Counsel – "The intent of the proposed changes to Garbage and Refuse code revisions are in no way meant to prohibit town residents from composting. The intent here is to address issues of properties that might be overrun with bulky couches or other items of garbage or garbage bags that are on their property and enabling the Town to provide a notice of violation with a shorter time frame for clean up and if that time frame isn't met to enable the Town to, through certain procedures, go in and do the clean up of that property themselves and then recoup the cost of doing so. There was never any intent to prohibit composting with these changes."

Melissa Cherubino – "I think some of the confusion is because within our minds we are thinking of it as the property maintenance code and of course that is very similar in how it is written and it does not apply to composting."

Courtney Heinel - "We didn't change the definition of garbage, that was a

definition that has always been there."

Councilman Martin – "I would further add as evidence to that in the time that I have been here, I have never heard of violations being sought for composting. So, in practice and in administration that is not the case. I think the law is operating properly and the one change being made here was to the time frame and not to definitions and that should be pointed out. This is a long-standing definition and properly applied. I don't see by virtue of the record that there is any cause for concern here."

Discussion...

Councilwoman Wierzbowski – "I would like to point out that the length of this list is greatly shortened from years past. I think it is a testament to the decision to go to the automatic water meter reading system that we installed a couple of years ago. I would like to thank all of the people who went along with that. This is a testament to the efficiency that was going to happen and the fact that there is approximately eleven (11) properties as opposed to the pages and pages that we used to have and this is something to note."

Councilman Godlewski – "Is it possible to explain the two (2) largest changes, one for \$55,000 and one for \$25,000?"

Supervisor Koetzle – "Both of those were manual commercial reads that were incorrect. We had to go back and rebill those because they were still on the manual read and through this COVID situation there was some difficulty getting to some of the meters and there were some incorrect readings that had to be adjusted. The 127 Maple Avenue is all the same thing, new owners and the previous owner was billed prior to the mailing so we had to fix it. The Petralia's had a meter swap, the old meter was an incorrect reading."

Councilwoman Wierzbowski – "The properties that this section targets in general are properties that have a history of issues and violations and by the time we get to the point where the Town is going to actually go in and spend time, money and effort cleaning up a property that has the type of violations that requires the Town to clean it up it has been a while. Councilman Aragosa – "There was a comment made at this meeting about the COVID pandemic being over. I really feel that it is important that we consider those types of comments before make them. This event is maybe in a pause or it has slowed down but it is not over. So public officials need to think about that before we say something."

from the standpoint of trying to be positive and note the improvements that have been made by everybody being so diligent and so responsible. There is hope for a brighter time coming out of this and all of the hard work has not been continuing for not but it is starting to show some real benefits. That was the spirit in which the comment was offered."

Supervisor's Comments

Supervisor Koetzle shared the following information:

We did get our second quarter Metroplex Sales Tax check which actually covers March, April and May. That was down 12% from last year. It is not as bad as we expected or we were fearful of that's good. March was fairly solid before the collapse of April and May. We expect our next quarterly check for June, July and August to be down about 15% based on these trends. We can only hope that we get some kind of rebound in the fourth quarter. We are still projecting now for budgeting purposes about \$150,000 shortfall in this revenue line. I have sent our District 3 legislatures and the County Manager a letter inviting them to come and speak to the Board at our work session in September. I have not heard back. I did get an email from one of the legislatures today that they are still negotiating and they really don't have any information but as I tried to explain we really need to know where we are with this revenue line as we try to put together a budget for 2021.

Our cable franchise revenue for the first half of 2020 was \$179,000 and that is down from \$189,000 same time last year. The cable franchise fee is going to continue to drop because people are continuing to cut the cord. That revenue line is not going to be where it was in the past.

We are waiting for the release of next years retirement rates from the state Comptroller's Office. They typically get it to us in August. Here is another huge piece of the budget that we don't have and understanding of right now. Our retirement bill for 2020 included significant increases for both police officers and the non-police employees at two (2) different rates but both were raised last year. Employee retirement is one of our largest expenses. It's over one million dollars a year to the Town.

Our new on-line payment for water bills proved to be very popular and effective. We had 535 people pay on line. It helped us keep people out of Town Hall which is good with COVID. It resulted in a reduction in unpaid water bills even during this financially difficult time.

The 2021 Budget Forums will be held on Wednesday, September 16th here at 18 Glenridge Road as part of the Town Board Meeting and Tuesday, September 22nd will be held at the Senior Center, Worden Road at 7:00 PM both nights. It will also be on the webinar.

We are just about sold out of tickets for movie night. We had a great

response from our residents. We are all sold out. First National Bank stepped up and they sponsored \$600. Storied Coffee is now involved and they are going to be there. It is just a great story of businesses coming together supporting other businesses. They need it and we need to do everything we can to help them. I want to thank everyone that supported this. What a great success this was!

We are having a little operational issue with courts and our front office. Since courts have opened people are coming in and they are congregating right here in the lobby as they always do. They are not social distancing; some don't have masks on and some of them are coming into our area. I believe it is becoming unsafe for our staff and our residents. We want to try to figure out a way of accommodating everything in this building. We are kicking around ideas and one of the ideas is we may consider closing Town Hall on court nights at 4:00 PM, moving our hours from 9:00 AM – 5:00 PM to 8:00 AM – 4:00 PM because they congregate starting at 4:00 PM in the front hallway. We thought of closing the doors to the front offices at 4:00 PM and letting the residents use our new window but they are still being exposed to people not practicing social distancing or having a police office in the hallway at 4:00 PM which will cost more in overtime. As we get into fall and winter it is going to be more difficult to have people outside in the rain and snow. No decision has been made yet but we are looking at all of the different options."

Councilwoman Wierzbowski – Read the entire resolution "I have known many of the departments officers for most of my adult life. Seeing that cartoon in the paper made me SICK TO MY STOMACH! The vast majority of law enforcement that I have had the honor of working with in my over twenty (20) years of public service myself, are here to help us, protect us and defend us and whether it's an opinion or not it was in exceedingly poor taste! I can't imagine how any police officer who woke up that morning and looked at their paper and saw that cartoon must have felt in their heart. I heard a song on the way to this meeting by an artist named Thomas Rhett, and the one refrain said, "in a world full of hate be a light, if you do someone wrong make it right". With this resolution, which I support, I'm calling on the Gazette to make it right! This was wrong, this went too far and crossed the line."

Councilman Martin – "I just want to reiterate and I agree 110%. This is just an awful, awful thing to publish and it is deeply, deeply offensive. The nature by which it was done and this broad-brush image that it paints is just awful and offensive. I have been making at the past several meetings supporting and making sure I mention the fine service of our police men and women and our department. I will continue to do so. I agree with Councilwoman Wierzbowski, they deserve an apology from the newspaper formerly to that department and many across the region. This is completely inaccurate, completely unconstructive to a very important issue and does the exact opposite towards any healing, unity or solutions to where there are problems. This is just irresponsible, offensive and I join with the expectation of an apology to the men and women of this department."

Councilman Aragosa – "Councilman Godlewski and myself talked about this ourselves and we are glad there is a motion in front of us that we can support in a bi-partisan sort of way to let the people at the Gazette know they have done an aggreges wrong to policemen of all departments. It was a bad thought out poorly thing for them to do."

Councilman Godlewski – "I thank Jim and Gina for putting this resolution forward. As a society we are going distant in a completely polarizing manner and it is important that these things are talked about. A couple meetings back I expressed my support for different things that are happening in society and I voiced an opinion about

a resident in my neighborhood having a sign indicating black lives matter among a number of other things and I would proudly display a sign like that on my front lawn. I think we are looking at these issues with a broad-brush. One can say black lives matter and one can equally say I proudly support law enforcement in my town and in this country. For me I try and think about this in more of a personal way. I try to go beyond Mike, the lawyer for DSS, Mike the town councilman for Glenville and think about member of law enforcement that I know. These are friends, these are I remember Mike who is a police officer locally being my fifth grade classmate at Pinewood Elementary, I remember Matt who is a detective locally being one of our catchers on the baseball team, I remember Billy who is a detective locally played basketball with him growing up, another Mike who is an officer locally who I play baseball with. My daughter's first birthday is coming up and we are having a party for her, having limited guests because of what is going on, two of the attendees are state troopers. We all have rights but with rights come responsibilities and there is freedom of the press in this country and that goes to the highest court but with rights comes responsibilities and the media should be focusing on ways they can bring people together and not divide us and this political cartoon furthers a narrative that will divide us and force people into corners when we really should be focusing on talking about these issues and figuring these issues out."

Supervisor Koetzle - "A lot has been said by our board members. I will say that this is something that I spent a lot of time on today with the Chief, Gina and Jim. I have been on two phone calls with the Gazette, one with the publisher and one with the editor. We had very good dialogue, I would say a positive dialogue and a dialogue that I think needs to happen outside of just two people on a phone call, it needs to happen in the community. I am not going to rehash what was expressed already because you all already talked about the support for our police officers. I want to say that when I saw that cartoon I was shocked; I was shocked to the core that something like that we put into a newspaper in this community. It was a broad-brush, it was a stereo type that only worked to inflame hatred between people, it was unfair, it was not true, it perpetuated hate. I put the same question to both the publisher and the editor, here is the test, if it was any other way, if it wasn't law enforcement and it was anything else that you did something like that to would that fly? Why is it only okay when it is law enforcement? It was hateful, it was wrong, it demeaned people, men and women who are putting their lives at risk for doing a job. They didn't ask for this but they are out there protecting this community. It was particularly personal to me because I work with these men and women every day. I tried to explain to both the editor and the publisher this is just nameless, faceless people these are people in our community. Eighteen out of our twenty-four officers live in this community. I see it in their eyes, I know what they are going through and the Chief and I have had a lot of conversations about that. I know that we are better than that cartoon, I know that that did not depict the people of Glenville. Whatever is going on anywhere else in the world, I am telling you that did not depict the men and women of the Glenville Police Department! I feel adamant and strongly that this resolution needed to be put forward, we were counseled by a variety of people just to have some comments on it but I thought it needed the full weight of this Board behind it and people in this community understand that we are supporting our staff members here. These are employees of the Town and they are well trained and well lead men and women who are doing a good job for us every single day and I am proud to be a part of the sponsors of this resolution."

Councilman Godlewski – "I understand that the Ethics Board met recently and that you attended the meeting. I was wondering if you could just update the Board as to what was discussed at the meeting and when the next meeting will be?"

Courtney Heinel – "We asked for comments by Friday and we scheduled our next meeting for next Wednesday at 1:00 PM."

Supervisor Koetzle – "So that would put us in line for calling for a public hearing on September 16th for October 7th and then action could take place as early as October 7th. They are looking at it and providing input."

Councilman Martin — "I just want to thank Courtney; you did an exceedingly good job explaining the law. You certainly have done your homework in preparing these revisions and it was a very informative session and I was especially pleased by the dedication of those people on the call.
