Supervisor Koetzle called the meeting to order at 7:00 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Supervisor Koetzle – "We are removing Item #16 and Item #17 from the agenda. Both of these resolutions call on the Governor to deem some of our employees as essential employees but the entire municipal staff is already being deemed as essential so those are being removed from the agenda."

Town Council Reports:

Councilman Godlewski – "I want to acknowledge the history of the fact that we saw inaugurated today our first female vice president. It is something that is frankly overdue in our society. In that respect that we are advancing in gender equality it's a great thing in American history."

Councilwoman Wierzbowski – "I have a couple of items. First I would like to offer my congratulations to all of the fire department officers who are now serving for the year 2021 in the town's fire departments. All of our fire departments with the exception of Scotia Fire Department are volunteer and these members go over and above responding to calls. They make sure the members are trained, they make sure the equipment is in order and they make sure that leadership is there so everyone goes home safe at the end of the day. I wish them all a safe and successful 2021.

I would like to offer my sincere condolences to the Coppola family. Chief Andy Coppola and his wife lost their sone Alex last week suddenly. Alex was a member of the Alplaus Fire Department for a number of years. He was an exceptionally kind, generous and funny young man. He will be greatly missed."

Councilman Martin – "I have been doing drive-thru food pantries for quite a while now. The need is getting greater. The Schenectady Foundation reached out to Justin Cook from the Village. Justin and his group from the Beukendaal Mason's Society will be doing a pantry Collins Park in February. He reached out to me and asked if the Town and the Village would be interested in doing a joint venture sometime in March. For us it means not much more then some help with logistics, some tables, maybe some police presence and getting some volunteers out.

Andy Coppola has been a friend of mine since we were young. I can't say how sad I am for him. His children grew up with my brother's children, they went to Glencliff together."

Councilman Martin – "On the continuing advance with the Zoning Revision Committee we have several things coming through again this evening. We met January 7th virtually and we have some more things that we are bringing forth tonight.

I would like to express my condolences to the Coppola family. It was tragic news. They are certainly in our thoughts and prayers."

Supervisor Koetzle – "I do join my colleagues in extending my condolences to the Coppola family. Andy and his wife, Tom and Cathy and the entire family. They know that we are here for them and to help them any way possible. We are praying for them.

Moving on to our "Employee Service Awards". This is something that Councilwoman Wierzbowski had us start last year and we wanted to continue it going forward. Unfortunately, we can't do it with the fanfare we did last year but we do want to recognize the service of our employees to this town. As I stated in my State of the Town, last night, I am extremely honored and privileged to be working with these people each and every day. They have worked particularly this last year under very difficult circumstances and they came to work every single day delivering the services to our residents. It's right that we take a moment to honor them. I had the opportunity to pass out the awards to each employee personally today except for highway, which I will be doing later in the week. We will move on to our presentation by the Chazen Companies. This is something that Melissa and I have been working on with the ADA Transition Plan.

Ethan Gaddy, Chazen Companies Planner – I have been working with Melissa and Carrie Ward, Traffic Planner with CDTC on an ADA Transition Plan for the past few months.

No one wished to exercise the privilege of the floor

Supervisor Koetzle shared the following information:

I received a call from the County Manager on Monday looking for a list of our employees prioritized by how we would want them to be vaccinated with contact information. So, all municipal employees are viewed as frontline or essential workers. Jason, Vicki and I worked on a list for the County and it was delivered to them yesterday. We are starting with any employees over 65 and then moving to any first responders and then to support staff from there. Our employees will be getting a call from county health to set up an appointment within the next week or so for the vaccination.

Last night we had the State of the Town, it was a virtual event. Thank you to all who attended. We had over 120 who attended.

Chief Janik and I will be starting our Police Reform Commission meetings tomorrow. This is an executive order handed down from the Governor to take a look at policing policies within the community. It is a virtual meeting. Earl has been working with the Chief and I on an outline and an agenda and how we are going to proceed with that. That report will be due to the board and after that the board reviews it and there is public input then we will adopt it. It has to be to the Governor by April 1st.

The other thing that has to be to the Governor by April 1st that we are working on and Earl is working on it with be as well is our pandemic response plan that is going forward as well. I need to deliver the plan to the union heads by February 4th and that also has to be to the Governor by April 1st.

Supervisor Koetzle moved ahead with the agenda.

Discussion...

Councilman Martin – "Essentially what we are doing is increasing some of the fees a little bit and detailing others. For example – demolition fees were always \$50.00 for residential building, now we are breaking that out to say a residential building of 10 to 1,000 sq. ft. at \$50.00, 1,001 to 2,500 sq. ft. at \$250.00, 2,501 to 5,000 sq. ft. at \$500.00.

We are increasing the inground pool fee from \$75.00 to \$100.00. There is a similar breakout detail for the demolition of non-residential commercial buildings and we are adding a re-inspection fee where there has been a two-time failure and if we have to come back a third time it is \$150.00, same way with a site-plan review for resubmission it is \$150.00. Zoning certification, checking to make sure that the project complies with zoning is \$25.00.

Those are some of the changes being made. It is something that I support because I believe these fees are a benefit of those who access these services and although they are not intended to pay for the entire cost of the service they are intended to try and offset the cost to the taxpayer in the community."

Supervisor Koetzle – "This is an outgrowth of our budget process from the summer where I asked the department heads to look at their fee schedules and to compare them to other municipalities and they did that. They found that we were out of line, much lower. We looked at, talking to our staff, how much time was taken on these particular tasks and we found that they were just out dated. We haven't addressed this in many, many years. So, this would really bring it in line and update the fees."

Supervisor Koetzle – "This is the important piece of the solar overlay district. It is going to allow us to be able charge what we call a public benefit greenspace fee for the solar farm, itself. It is in the site plan section of the law, so it is separate from the one we just did. This is based on the sub-division recreation fee that we currently charge for single family homes, which was a thousand dollars for lots. One of the things that I talked about in the State of the Town yesterday was the reality is 50% of our neighborhoods were built prior to 1979 and only 3% since 2010 so this is a good opportunity for us to find a way to augment that as we continue to hopefully direct more single-family homes but in the interim this will help make sure that our parks continue to be fully funded."
