# MEETING OF THE TOWN BOARD TOWN OF GLENVILLE MARCH 17, 2021 AT THE GLENVILLE MUNICIPAL CENTER 18 GLENRIDGE ROAD, GLENVILLE, NEW YORK

Supervisor Koetzle called the meeting to order at 7:00 PM;

Supervisor Koetzle asked the Town Clerk, Linda C. Neals, to call the roll.

Town Council Reports:

Councilman Godlewski – "The Glenville Y is opening back up on April 5<sup>th</sup>. The Governor announced today that gyms and some other establishments like bowling alleys will no longer have a curfew.

The food pantry that we talked about at the last work session is now scheduled for March 24<sup>th</sup>. Cars can start to line up at 6:00 pm. Volunteers can arrive at 4:30. It is going to be at Collins Park.

I just want to extend some encouragement to our State Senator Tedisco who continues to raise the issue of the St. Clairs pensioners going back a year or two now, who received unfortunate word that they would be having their pension cut off as a result of mismanagement of their retirement funds. It's an important issue for every local elected official to not to lose site that there are 1,100 people locally who are out of luck due to no fault of their own. Senator Tedisco brought up the idea that there should be relief included in the federal relief that was passed recently and that certainly sounds like something that should be considered."

Councilwoman Wierzbowski – "Just a reminder to our residents, the weather is warming up and kids are going to be out on bikes and out in the street. They may not be paying as much of attention as they should be. As you are driving through the town and you see people out walking and you see kids out on bikes and families out trying to enjoy the nice weather as we all start to emerge from last year try to be extra aware and be a little extra careful."

Councilman Martin — "I just want to extend thanks to Chief Janik and the committee that worked on it. I think there is a lot of good information in there and there is a real solid basis for us to move forward on. I also came away thinking how fortunate we are in the current condition of our police department. I think they are a model for the region and I think they do a fine job and it is just a matter of now seeing if we can tweak some things here and there to make things even better. I did read the report in detail and I want to thank all of those who worked on it and again the fine work our officers do on a daily basis."

Councilman Aragosa – "Next Monday night GECC is meeting...Freemans Bridge Road solar project at the old Van Curler Greenhouse site...will be on the agenda. I'm very thankful to Stewarts for donating 3,000 bags for our food event in Collins Park."

Supervisor Koetzle – "Item No. 5 on the agenda is a public hearing regarding proposed amendments to Chapter 255 "Vehicle and Traffic" of the Coe of the Town of Glenville – "Failure to Obey an Overhead Clearance Sign", "Penalties for Offenses" and "Authority".

Supervisor Koetzle opened the public hearing at 7:10 PM

No one wished to speak; Supervisor Koetzle closed the public hearing at 7:11 PM.

The following people exercised the privilege of the floor with written comments:

Mr. Hyde wanted to talk about the bridge issue and his comments are summarized as follows:

- There have never been these issues on Glenridge before it was "modernized".
- He finds that the people hitting the bridge are not local drivers, but "out-of-towners" who are looking for a shortcut to 88 or 90 it seems that the Target and Price Chopper trucks, for example, seem to come from Saratoga or Schenectady.
- The drop bar needs to be placed in front of the first bridge (the 15' bridge) to stop the truck from getting into a difficult position.
- Laser beam needs to be deployed with flashing lights at 146
- A truck route needs to be established at 146
- Not really in favor of the fine unless it's used to deploy technology

Supervisor Koetzle shared the following information:

Melissa and I had a call with the Department of Environmental Conservation (DEC) regarding some ongoing projects around the Town. The two (2) projects that we talked about almost exclusively were the Kenco Project, where we are with Kenco. We are trying to get DEC back to finish the clean-up on that. As you know, years ago we got the free water line in for the folks on Sunnyside Road. Then Hoosick Falls started and the state diverted resources from Glenville and other areas to Hoosick Falls and now we are at that point where we are trying to get them back to Kenco and they did indicate that there is some movement in that area. They will be coming out with some further guidance as to what they are going to do forward to finish the clean-up at Kenco in the near future.

The second one that we brought up that isn't on their radar is the Kivort site to talk about making it a brownfield. Obviously we would need the owners to make that happen. The owners don't seem interested in that at this particular juncture. Apparently they had a brown-site application in and it has been pulled out so there is really nothing that we can do at this juncture with that. We did talk about it and we did talk about the need to focus some efforts on getting that site cleaned up and hopefully redeveloped in some way.

To update you a little bit on the bridge. We learned today that CP Rail will be installing crash bars. After DOT says you can't install crash bars CP Rail is going to install them. The problem is the crash bars are going to be located very close to the bridge. The question is will they actually be effective since they are going to be so close to the bridge. They will be steel crash bars. So, the debris is going to happen before the vehicle hits the bridge. I am concerned for a couple of reasons. First you need to stop the traffic before it leaves Rte. 146, it's going to be a problem and this doesn't do that. They did say that the bridge can't take another hit, so it must be impacting the bridge at this juncture. I think all it is going to do is move the hit from the bridge to the bar.

The Solar PDD is coming in for Freemans Bridge Road, supposedly March 22<sup>nd</sup> so we will have that going forward into the April work session. It is going to the Glenville Environmental Conservation Commission next week.

The Senior Tax Program has wrapped up very quickly. We had such high demand for it they finished them very quickly like within two (2) days the entire program was closed. We did as many as we could with the resources that we had. We still are

looking for folks if they want to help us with that. We were successful to get the AARP program back after the H & R program came on, AARP decided to come back and do a limited program.

I had a nice conversation with the County Attorney today on a project regarding Wolf Hollow Road. They are looking to turn that into a hike trail/nature trail. We talked about the process there and what they need to go through to make that happen. I think there is going to be a private entity that will take it over as a hiking trail. A subdivision will be required so, we are working with the County to get that through our Planning Board which will probably take two (2) full months.

We received a donation from Stewarts. I want to thank Stewarts, they are a great community partner, to go towards our inclusive playground. They awarded us \$1,500 to go towards our playground.

Lastly I want to update you on the Youth Council thing we talked about. I had an opportunity to host a Youth Workforce Development Summit with high schools and some local businesses and towards the end on the agenda this idea of a Youth Program was brought forward to them and they seemed very opened to it. They asked for time to talk to their people. We are going to circle back on some other things and they will let me know if they are opened to the idea."

#### Discussion...

Supervisor Koetzle – "I want to thank the Chief for all of his hard work and leadership on this. We spent a lot of time together doing this. Thank you to the Committee who couldn't be here tonight. They worked very hard on this, they gave their time and helped us. This was an executive order that came down from the State which required us to perform a comprehensive review of strategies, employment practices and policies for the purpose of addressing the needs of the community served by the police agency and to promote community engagement to foster trust, fairness, legitimacy and to address any racial bias and disproportion policing of communities of color.

Through the process we learned a lot about ourselves, we listened to the community and I think we reacted. I think the Chief and the police department acted very quickly to some of the suggestions. It didn't really give us an opportunity to put it in as a plan because he already enacted the reforms like the next day. We did hold public meetings as we talked about, that were directed by the executive order and the draft form was prepared and provided to the public and reviewed to be heard. I received 5 or 6 emails. It is the town's position that this meets the directive of the executive order and certification that I will be sending into the State of New York tomorrow with my transmittal certification form."

Councilwoman Wierzbowski — " I would like to echo my colleague's comments and gratitude to the members of our community that came out and were willing to take time out of their busy lives to help our police department improve. It's wonderful when residents engage and they were engaged in a very positive way to help us get better. I would like to commend you, Chief Janik, because it's not easy to take a hard look at your own profession and a hard look at your own department and the men and women who serve with you every day and turn a critical eye to and I think that you did a fine job of doing so. I would just like to say thank you and tell the officers that assisted you with the report and the gathering of the data. I hope this is a spring door going forward to kind of take a look at it even more often. It sounds like you put some things into place that will allow us to track statistics better and keep an I on things and make sure our officers are treating everybody who comes into and lives in our town equally with respect no matter what the situation is going forward.".

Councilman Aragosa – "Thank you Chief Janik for you work on this and the committee that you had working with you and Supervisor Koetzle for getting together and getting it done. The need for supervision is very important amongst your ranks. I feel we need to move forward and fill the positions that are missing. We need to make sure that we get that done."

Councilman Godlewski – "Thank you Chief Janik and Chris for their efforts with this. It is always nice to have data. Thanks to the residents who help provide the data. Things are moving in a positive direction here in Glenville and the statistic that jumped out to me was safety statistic. That our residents overall feel safe in Glenville."

**WHEREAS**, the Town of Glenville sought volunteers to serve on a task force to perform the comprehensive review and develop a reform plan; and

**WHEREAS**, a task force of 15 members was constituted, which held a number of public meetings to discuss the directives of Executive Order 203, study the issues raised by the Executive Order and identify strategies for effective policing standards in the Town of Glenville; and

**WHEREAS**, the task force held five public meetings and conducted a survey on the community's interactions with the Town of Glenville Police Department; and

**WHEREAS**, a draft reform plan was prepared and provided to the public for feedback and review with all public comments being heard and reviewed; and

**WHEREAS**, the Town Board has reviewed the proposed plan as well as public comments and supports the review and plan set forth therein.

**NOW THEREFORE, BE IT RESOLVED** that the Town Board of the Town of Glenville hereby adopts the Town of Glenville Police Reform Task Force Plan; and

**BE IT FURTHER RESOLVED** that the Town Board directs the Town Supervisor to execute the certification of the plan and before April 1, 2020, transmit the certification and plan to the New York State Budget Director as required by Executive Order 203.
