Town Council Reports:

Councilman Godlewski: Just to quickly say congratulations to the Burnt Hills Boys Cross Country Team that's a fantastic honor to become State Champions. You will be formally recognized in a few moments but I wanted to say my congratulations. I wanted to wish everyone a Merry Christmas, Happy Holiday and Happy New Year. Just a couple things to report, I attended with my wife and daughter the pancake breakfast at the East Glenville Fire Department, it was a very nice event. Santa Claus had a striking resemblance to a gentleman that is involved with the Glenville Rotary and it was very calming to my daughter. So, I really appreciate that. Certainly, appreciate that some of the firemen showing her around the truck. It was very moving and it also coincides with a firefighters faze that we have. Wanted to, in light of, kind of where we are headed with the mask mandate, to just recognize some small businesses that I recently patronized. Just kind of give everyone a reminder particularly now the mandate will affect small businesses and remember to shop local if you can. I was able to get over to Lily's Cafe, Councilman Martin has mentioned Lily's a couple times, for lunch and it was fantastic. Also, I'm pretty ashamed to admit this but I hadn't yet been to JT's Café, which is on the other side of town from where I live, also fantastic. I had a great lunch; I love their homemade chips. We also went to Wolf Hollow Brewery for a gingerbread house making event, they do a lot of different seasonal events. We were there for a pumpkin carving event in October and check them out for different activities for family friendly activities. Also, I very excited to do this plug for anyone who grew up in the 70's or 80's like I did, the new Ghostbusters movie is showing at the Scotia Cinema for one more day at four o'clock. I had the figurines and house and the proton pack and everything. I pretty much wanted to be a Ghostbuster, I settled with attorney and Town Councilman. Councilman Martin- First of all the CFA awards came out today, the Consolidated Funding Application Awards for the NY State Grant Funding Program. I think the Town got two awards and I just wanted to say that's fantastic. I know Chris will get into more detail but was very glad to see that the hard work of our Planning Department putting together those applications and to see that funding coming to the Town is wonderful.

You could gain a lot of knowledge from him, a guy who was out in the world for a long, long time, he lived to the ripe old age of 90 he was healthy and sharp. He was an advocate for people right up until the end and thank you.

Supervisor's Comments to the Board: I do want to start with taking an opportunity to honor Mike (Aragosa) with a proclamation from the Town for all of his work. I do want to extend our thanks and appreciation for all the work that you've done over the past four years on behalf of the Town of Glenville. You and I, as I mentioned earlier, have known each a lot longer than just the past four years. I do want to say that I've

always known you in all our time together on the Board we may have had a few disagreements here and there but you always acted as a gentleman and professional. I do want to thank you for that and thank you for your passion and the perspective you brought to the Town Board. As you said in our conversation since the election, I'm sure you will stay involved and still be around and we will be able to call on you for your expertise and whatever it is else that we may need you to do. If you have a moment and want to come down, I'd like to present to you the Certificate of Appreciation: "To Michael Aragosa for your years of service to the Glenville Town Board", Thank you and congratulations.

I only have two quick things to I want to mention, three actually. We were planning a Holiday Party as we did previous years before last year, right in this room with Town employees. We were just started talking about and selecting dates and then the mask mandate hit. Obviously, it's not something we can do right now because it's just too much to put 60-70 people in this room and keep mask on and eat. That will be postponed unfortunately and we will see how that goes and we will try to do something. Looks like for a second year in a row we will have to cancel out holiday party.

As for your planning January 5th is our next Board Meeting, it's the Organizational Meeting. I've been working with Councilman Godlewski on the swearing in that will happen prior to the meeting, so the meeting is at 7 PM, the swearing in of the new elected will be at 6 PM here in this room. Then we will go into our Organizational Meeting.

Other than that, I wanted to update you on the fact that Councilman Martin talked about the two CFA's we were awarded. The first is the Maalwyck Park kayak launch down at Maalwyck Park. This will allow us to finally construct our car top boat launch, will help us with our shore line parking, make resiliency improvements down at Maalwyck Park, and also help us to repave the road. This is a project that Park Planning Commission has been trying to advance to of course trying to connect our park to the water way better. So, we are excited about this one. We are also excited that we finally got the Van Buren Road Trail Project funded. That will allow us to put a pedestrian path from route 50 to the Andersen Park. What's significant about that is, that is the last link in this grand vision that we had twelve years ago when we said we were going to connect our neighborhoods, our commercial corridor and our parks. Everybody laughed, I don't know if you remember this, everyone said you building a park, you are going to be building a sidewalk to nowhere. We gave them little pieces here and there and this is the final link. We are very excited about this because it's going to connect two of our major parks, to two of our major neighborhoods, to our major commercial corridor. We are finally going to have that accessibility, once you get into Andersen now you are into our trail system, we built a couple years ago and you are really connecting miles and miles of people to different pieces of the town. This is on top of the sidewalks we recently did for Sacandaga Elementary School, that we are doing for Alplaus, Burnt Hills on Lake Hill Road, Freeman's Bridge Road, Dutch Meadows and along the river to Scotia. We are achieving the connectability, the pedestrian connectability that we have been focused on the past twelve years. So, this is exciting, everyone's asked me when it going to be ready let's get through getting the contract done and I'm thinking it's probably going to be a two-year project. We have some challenges but I'm very excited about those two projects and that's all I have.

**AUTHORIZATION TO ENTER A CONTRACT FOR DESIGN AND CONSTRUCTION
INSPECTION OF FREEMANS BRIDGE RD MULTI-USE PATH**

WHEREAS the Capital District Transportation Committee (CDTC) and NYS Department of Transportation (NYSDOT) awarded the Town of Glenville State Transportation Improvement Program (STIP) funds for the design and construction of a 4800 LF multi-use path on Freemans Bridge Road between the bridge and Dutch Meadows Lane that includes three crosswalks and a pedestrian arm at the railroad (RR) crossing at Maple Ave (hereinafter the "Project"); and

WHEREAS the Town issued a Request for Qualifications (RFQ) for design and construction inspection; and

WHEREAS the Town of Glenville, Schenectady County, New York (hereinafter the "Town") has established that the proposed project is of significant public benefit to the Town residents; and

WHEREAS five consultant design professional firms with qualifications for locally administered federal aid projects (LAFAP) submitted qualifications and an interdepartmental committee in town hall selected Creighton Manning Engineers (CME) for the project design;

WHEREAS Glenville Town Board authorized entering two contracts with CME and FOIT ALBERT respectively in April 2021, but the granting agency NYSDOS has asked that CME merge the contracts for budget and MWBE reporting purposes; and

WHEREAS CME submitted its amended contract for a not-to-exceed cost of \$52,815 which includes FOIT ALBERT as subcontractor for construction inspections; and

WHEREAS Glenville's Town Attorney notified FOIT ALBERT in writing that the existing contract is null and void; and

NOW, THEREFORE, BE IT RESOLVED THAT,

The Glenville Town Board Authorizes the Supervisor to sign the amended contract with CME for design of the Freemans Bridge Road Multi-Use Path with FOIT ALBERT as subconsultant for construction inspections.

This resolution will take effect immediately.
