WHEREAS, the Schenectady County GOP has otherwise satisfied all necessary provisions of the park permit process including fees and insurance requirements,

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Glenville hereby waives Town Code Chapters 195-14 B 5 and 195-16 for the activities proposed in the Schenectady County GOP's park permit application for use of Indian Meadows Park to conduct a Family Fun Day on September 17th, 2017.
